1. The budget adjustments on this line relate to:

- a) £353k earmarked carry forward for Expenditure on initiatives for increasing 2 year old provision. Agreed by the Forum July 2015.
- b) £211k relating to anticipated additional funding for Disadvantaged 2 year olds based on increases in pupil numbers.
- c) £305k relating to anticipated additional funding for 3 and 4 year olds based on increases in pupil numbers.
- d) Less £178k relating to a prior year adjustment for 2014-15 Early Years pupil numbers.

2. The budget adjustment on this line is the £256k earmarked carry forward for primary admissions growth as agreed by the Forum in July 2015.

3. The adjustment here is the additional income anticipated from the EFA to fund the increased expenditure referenced in Notes 1b) and 1c) and the reduction relating to prior adj in Note 1d)

4. The £609k adjustment is the earmarked carry forward that the Schools Forum agreed to fund increased expenditure referenced in Notes 1a) and 2.

5. This is unearmarked carry forward that was not committed for use on any particular service by the Forum in July.
