7/18** **REVIEW OF THE STATEMENT OF PRINCIPLES FOR GAMBLING PREMISES IN STOCKTON**

The Licensing Team Leader presented Members with a report which detailed the revised Gambling Statement of Principles following the consultation on the draft Gambling Statement of Principles which was considered at the Statutory Licensing Sub Committee meeting held on 10 July 2018.

The draft Gambling Statement of Principles was published for consultation. The consultation included stakeholders such as the Gambling Commission, trade associations, licensees, children's services and a local residents group.

The consultation was published on the website and a notice was placed in the public notice board in the customer service centre.

During the consultation process comments were received from the Regional Compliance Manager at the Gambling Commission regarding Primary Authority schemes detailed within the statement stating that these schemes no longer existed as described.

It was suggested therefore that as Primary Authority schemes could change

during the length of the statement, it would be better to omit the detail of the schemes and instead provide a link to the Gambling Commission site where up to date information could be found.

The Gambling Commission also commented that local area risk assessments which were completed by the licensee should be held on the premise for inspection.

In addition it was suggested that sight of local area risk assessments should be incorporated into the inspection criteria and requested during annual inspections.

Members would be aware that the current Statement of Principles was adopted in January 2016 and Licensing authorities were required to prepare and publish a statement of principles every three years when exercising their functions under the Gambling Act 2005.

The gambling policy had been reviewed in accordance with the Gambling Act 2005 and the revised statement reflected legislative changes and those comments received during consultation.

The current review would conclude with a revised Policy coming into effect on the 1 January 2019 following consideration by Cabinet in November and Council in December.

The main topics discussed were as follows:

- How local area risk assessments were undertaken.
- The local residents group used in the consultation.
- Members requested the wording to point 5 of the report be amended and incorporated within the inspection form as follows:

'In addition it is suggested that sight of up to date local area risk assessments should be incorporated into the inspection criteria and requested during annual inspections'.

RESOLVED that:

- 1.Members give consideration to the proposed revised Gambling Statement of Principles.
- 2.Wording to point 5. of the report be amended as detailed above.
- 3.Members agree to the proposed changes to the draft for consideration by Cabinet on 15 November 2018 and Council on 12 December 2018.
