Gambling Act 2005 - Suggested Delegations

S154 of the Gambling Act 2005 states that all Licensing Authority functions under the 2005 Act are the responsibility of the Statutory Licensing Committee created under the Licensing Act 2003 except Resolution not to grant a Casino Licence (s166), Adoption of Policy (s349) and Setting Fees (s212). Passing a Resolution not to grant a Casino Licence (s166) and S212 is a Council function¹. Setting Fees (s212) is a Council function² which can be delegated by the Council to the Licensing Committee under s154(2)(b). Adoption of Policy (s349) is an executive function.³
