## The grounds of the representation is based on the following: (Please continue on a separate sheet if necessary)

The Environmental Health Unit are of the opinion that the steps outlined in the operating schedule are inadequate to prevent public nuisance.

There will be a greater likelihood of public nuisance associated with noise from clients using the premises as a result of the proposed extension in opening times and the use of the external seating areas. Environmental Health has received several noise complaints from the use of the external seating to the front and side of the premises as it has given rise to significant disturbance to residents within the vicinity.

There will be a greater likelihood of public nuisance associated with entertainment noise, and noise from clients leaving the premises as a result of the proposed extension in opening times and variation to allow regulated entertainment.

Environmental Health has contacted the applicant regarding proposed conditions and would recommend the following

- 1. The use of the front/side external drinking area by customers shall be limited from 09:00 to 18:00Hrs. There shall be no music played externally, and no use of flood lighting likely to cause a nuisance to local residential properties.
- The use of the rear external drinking area by customers shall be limited from 09:00 to 23:00Hrs. There shall be no music played externally, and no use of flood lighting likely to cause a nuisance to local residential properties.
