Pubwatch ban and Cleveland Police had received information that this male was attending

the George in contravention of his ban.

At 10.55am on the 14th January 2015 I attended the George and spoke to Mr Harker about

this information and other matters.

I advised Mr Harker that he would either have to ask his friend to stay out of his premises

as per his Pubwatch ban or that if he wanted him to come in then he would have to remove

his premises from the Pubwatch group.

Mr Harker said he would remove his premises from Pubwatch so I advised him to confirm

this with the then Pubwatch chairman.

On the 16th January 2015 I spoke to the Pubwatch chairman who confirmed to me that Mr

Harker had indeed removed his premises from the Pubwatch group.

At 1.55pm on Tuesday 13th August 2019 I attended the George with Sqt Higgins and an

officer from Stockton council licensing unit where we spoke to Mr Harker.

One of the conditions on the George licence states 'The licence holder and/or the

designated premises supervisor or a person nominated by them shall actively

participate and be a member of a Pubwatch scheme for an area within which the

premises is located'.

It pointed out to Mr Harker that he had removed his premises from the Pubwatch group but

he claimed he would be willing to attend meetings but he had not been notified of the

dates.

He did claim that attending the meetings is 'A waste of time'
