#### **SUMMARY**

The purpose of this report is for Members to consider an application for a review of a premise licence from Cleveland Police on the grounds of the prevention of crime and disorder and public safety.

#### RECOMMENDATION

That Members determine the application.

#### THE APPLICATION

- An application for a review of the premise licence in respect of Goldies Bar, 93 High Street, Stockton-On-Tees has been received from Cleveland Police. The application to review the premises licence relates to the undermining of the licensing objectives of the prevention of crime and disorder and public safety. A copy of the application and supporting evidence is attached at Appendix 1.
- 2. A copy of the current premises licence showing licensable activities and hours is attached at Appendix 2.
- 3. A map showing the location of the premises is attached at Appendix 3

#### **RESPONSIBLE AUTHORITIES**

- 4. A representation on the grounds of the prevention of crime and disorder and public safety objectives has been received from Licensing which is attached at Appendix 4 together with supporting documents.
- 5. A representation on the grounds of the prevention of crime and disorder and public safety objectives has been received from Public Health which is attached at Appendix 5.

#### **POLICY CONSIDERATION**

- 6. Members must carry out their functions with a view to promoting the four licensing objectives:
  - The prevention of crime and disorder
  - Public safety
  - The prevention of public nuisance
  - The protection of children from harm

7. Members are respectfully reminded of the need to give due consideration to Stockton Borough Councils Licensing Policy Statement and the Section 182 Revised Guidance issued April 2018 under the Licensing Act 2003 when considering this application for review.

Part 11 of the Guidance deals with 'Reviews' and at paragraph 11.18 it states:

".....However, where responsible authorities like the police and environmental health officers have already issued warnings requiring improvement – either orally or in writing – that have failed as part of their approach to concerns, licensing authorities should not merely repeat that approach and should take this into account when considering what further action is appropriate."

Paragraph 11.28 of the Guidance states:

"It is envisaged that licensing authorities, the police, the Home Office (Immigration Enforcement) and other law enforcement agencies, which are responsible authorities, will use the review procedure effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence – even in the first instance – should be seriously considered.

8. A copy of the policy documents will be available at the meeting for Members information and details regarding the full range of powers available to members can be found at Paragraphs 11.16 to 11.28 of the Guidance.

#### **MEMBERS OPTIONS**

- 9. Members are advised that under the provisions of Section 51(4) The Licensing Act 2003 the authority may, at any time, reject any ground for review if it is satisfied
  - (a) that the ground is not relevant to one or more of the licensing objectives, or
  - (b) in the case of an application made by a person other than a responsible authority, that-
    - (i) the ground is frivolous or vexatious, or
    - (ii) the ground is a repetition
- 10. If Members are not minded to reject the application, then under the provisions of Section 52(3) The Licensing Act 2003, the authority must, having regard to the application and any relevant representations take such steps mentioned in subsection (4) (if any) as it considers necessary for the promotion of the four licensing objectives.

The steps are -

- (a) to modify the conditions of the licence which could include reducing opening hours or requiring door supervisors at a particular time;
- (b) to exclude a licensable activity from the scope of the licence;
- (c) to remove the designated premise supervisor for example, because they consider that the problems are the result of poor management;
- (d) to suspend the licence for a period not exceeding three months;
- (e) to revoke the licence and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.

Where the authority takes a step mentioned in (a) or (b), it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.

Cleveland Police apply for a review of the premises Licence at Goldies Bar on Stockton High Street on grounds that it is undermining the Licensing objectives of the Prevention of Crime and Disorder and Public Safety.

Goldies Bar is located next door to Che Bar on Stockton High street and the two bars are operated by the same person, Mr Raffiq. Cleveland Police also apply for a Review of the Premises Licence at Che Bar and the grounds and circumstances for that application are interlinked to this application.

The concerns relate primarily to the management and deployment of door staff at both premises and how this mismanagement has been at times unlawful and potentially contributed to crimes and incidents at these premises.

Goldies has a Premises Licence enabling it open from 11:00 hrs to 04:30hrs seven days a week Goldies has a licence condition requiring a minimum of 3 door staff be present from 21:00hrs on Friday and Saturday nights along with Sundays before Bank Holidays.

Che Bar has a condition requiring 2 door staff from 9pm on Thursday to Sunday with a third doorman required on these nights after midnight.

Police became concerned that deficiencies in door staff numbers were being managed at both premises by deploying door staff from one venue to another as and when incidents of disorder occurred. Police initially held meetings with Mr Raffiq about incidents of disorder at Goldies on 12<sup>th</sup> June 2018 and 19<sup>th</sup> February 2019.

In March 2019 Mr Raffiq opened Che Bar next door to Goldies and much of the disorder at Goldies calmed down but was replaced by concerns of disorder at Che Bar. In August 2019 a man died at Che Bar after falling ill inside and the circumstances of his death are pending an Inquest.

At that time Police and Council Officers became concerned about allegations that Mr Raffiq was employing a doorman without an SIA Licence. Mr Raffiq was spoken to about this on 3 specific occasions and at each time Police and Council Officers were told the man was a Personal Assistant to Mr Raffiq and not working as Door Security.

Police have reviewed CCTV footage for both Goldies and Che Bar and have identified that the man identified as a Personal Assistant by Mr Raffiq is in actually fact regularly conducting activities that would require an SIA Door staff Licence. Although the illegal door man conducts his activities at Che Bar there is at least two occasions where he appears to get involved with Door staff activity at Goldies.

Furthermore Police have identified 3 other occasions when the condition requiring 3 SIA doorstaff to be present at Goldies has been breached. These dates are the 25<sup>th</sup> August, 19<sup>th</sup> October and the 7<sup>th</sup> December 2019

On the 27th December 2019 an incident occurred inside Goldies bar which resulted in the death of a male outside in the High Street. This matter is being investigated, however of note the CCTV footage shows the illegal doorman was working at Che Bar that night.

In summary there have been incidents of crime and disorder at Goldies in 2019. Management of crime and disorder at late night venues relies heavily on the use of door staff. To be effective there must be strong policies and procedures in place to ensure that door staff are deployed lawfully and in sufficient numbers. This has not been the case at Goldies and has undermined the Licensing Objectives

I am a Police Sergeant in Cleveland Police presently stationed at Middlesbrough Police station
in the Licensing Support Unit. I have performed this role for over 16 years and during that time I
have successfully completed the BIIAB level 2 National Certificate for Licensing Practitioners
and the BIIAB level 2 course in the Assessment of Licensed Premises.
Cleveland Police have instigated Reviews of the Premises Licences at Goldies and Che Bar on
Stockton high street. I have prepared a single statement as the premises are operated by the
same person and the issues at the premises are interlinked.
Goldies Bar is located at 93 High Street, Stockton. The premises Licence holder and DPS is a
man I know to be Paul Raffiq. He has operated the venue since August 2017. I have know Mr
Raffiq as a bar operator for many years and he has lots of experience at operating bars in the
Cleveland area.
Che Bar is located at 94 High street Stockton. The premises Licence Holder is a company by
the name of Yarm Property Management Ltd of which Mr Paul Raffiq is the sole director. Mr
Raffiq is also the Designated Premises Supervisor.

As detailed by PC Thorpe, Goldies has a licence to sell alcohol until 4am. Mr Raffiq employs a manager at Goldies bar responsible for the management of the venue.

Due to various reasons including the challenging nature of operating a bar/nightclub until late on Stockton High Street, Cleveland Police have a long history of interactions with the various operators of Goldies bar going back many years before the involvement of Mr Raffiq.

The first noteworthy discussions around crime and disorder during the tenure of Mr Raffiq happened on 12th June 2018 when PC James Johnson from the Police Licensing Department met up with Mr Raffiq to discuss crimes. The meeting was held at Stockton Police station and Mr Raffiq brought the manager of Goldies with him. Although PC Johnson has now retired I can say from his records that they discussed an incident on the 26<sup>th</sup> May 2018 where an altercation had taken place between a doorman and a customer. Mr Raffiq stated that he would speak with the head of the door staff company about the door man's actions.

At 10am on the 19<sup>th</sup> February 2019 I was present at Stockton Police station when PC Johnson and I held a meeting with Mr Raffiq and the Goldies manager to discuss further crimes at the premises. We were concerned that his door staff provider had taken on doormen from a neighbouring premises which had removed those door men following a review of their premises licence.

Mr Raffiq was shown 2 clips of CCTV evidence of incidents involving Door staff being heavy handed. Mr Raffiq informed us that he was aware that this had been happening and had taken the decision to end his contract with that door staff provider as he was not happy with how their door men were behaving. Mr Raffiq told us that he was going to employ and deploy his own door staff, which he was legally able to do as he holds an SIA licence himself. We also discussed the price of drinks at the venue and were told that the cheapest pints were £3:50 and the cheapest bottles were £1:50.

I can also say from PC Johnson's records that he spoke with Mr Raffiq after the Pubwatch meeting on the 7<sup>th</sup> March 2019. This was because of a promotion Mr Raffiq was advertising for the 8<sup>th</sup> of March where the first 30 people would get a free drink. Members of the Pubwatch were unhappy with this promotion especially as Mr Raffiq was the Chairman of the Stockton Pub Watch at that time. Mr Raffiq told PC Johnson that it was a one off event and was being paid for by the DJ to get people into his event.

In March 2019 Mr Raffiq started to operate Che Bar which had last operated as a Licensed premises under the name of McShane's

On the 25<sup>th</sup> August 2019 a male died after taking ill inside Che Bar. Staff had identified that the male was ill and called an ambulance but the man sadly died.

On the 27<sup>th</sup> August 2019 I attended a meeting at Che Bar which had been arranged by PC Thorpe to discuss the death of the man on the 25<sup>th</sup> August and some other incidents. Polly Edwards from Stockton Council Licensing dept was also present. Mr Raffiq was present along with his head doorman from Che Bar and the male manager of Goldies.

We discussed the incident involving the death of the man. I informed Mr Raffiq that there would be no formal licensing action taken with regard to this incident as his staff had identified the man's condition at the first opportunity and they had looked after the man whilst calling the ambulance.

We discussed door staff numbers and how they were managing people outside the venue particularly in relation to customers who were outside smoking cigarettes mingling with non customers. In relation to door staff numbers we expressed concerns that Che Bar and Goldies were being considered as one venue and door staff were being swapped between the venues to manage incidents. Mr Raffiq accepted that prior to the Bank Holliday Monday he had only had 2 door staff present at Goldies, one of whom was himself. This was a breach of the

I advised that both venues needed to be managed with sufficient door staff numbers that they would not need to call on the other venue's door staff. I also examined the door staff signing in book and expressed concern that the book contained entries that were not complete and did not specify the day the door man had signed in. There were very few records anyway as we were told the old records had been water damaged.

I requested that a new way of recording is introduced with a separate page/sheet for each individual day rather than a continuous log.

Polly Edwards asked Mr Raffiq specifically about a complaint she had received that the venue was employing a door man without an SIA Licence. Mr Raffiq stated that he employed a man as a Personal Assistant who was usually stood with Mr Raffiq when he was at the venue but he was not acting as a doorman. Polly Edwards stated if this male is not acting as a doorman he should not be dressed in black nor standing near the door.

Mr Raffiq agreed that changes needed to be made and agreed to implement minimum numbers of door staff at Che Bar reinforced by a Licensing Condition to be introduced by means of a Minor Variation which would be submitted by Mr Raffiq.

At 13:00 on Monday 2<sup>nd</sup> September 2019 I attended Che Bar with PC Thorpe and Polly Edwards for a second meeting with Mr Raffiq. Also present were the male manager of Goldies and the female manager of Che Bar. We discussed the potential new licensing conditions which Mr Raffiq was willing to submit on a minor variation. PC Thorpe showed CCTV footage of an incident on the 17<sup>th</sup> August 2019 which showed lots of people congregating outside of the Che Bar. This incident is event number SE19140993 and is listed on the table of incidents for Che Bar as number 17. We discussed the management of people in the smoking area and the use of barriers to manage people.

PC Thorpe continued to have dialogue with Mr Raffiq until a full agreement on the wording of new licence conditions was submitted by Mr Raffiq on 22<sup>nd</sup> October 2019

At 03:22 on Friday 27<sup>th</sup> December 2019 an incident occurred at Goldies bar which ended with a male dying outside the venue. This incident is being investigated by Cleveland Police. Two men were arrested in connection with this incident. The 2 men arrested are both SIA registered door staff. At the time of the incident they were not on duty but had finished work at a nearby premises. Both men had previously worked as doormen for Mr Raffiq at Goldies Bar. Both men have been released under investigation and conclusions should not be drawn on the cause of death until the investigation is concluded.

I spoke with Mr Raffiq on the telephone that day and arranged for an Officer to collect the door staff register on behalf of the investigation team. PC Westmoreland seized the signing in book from Goldies the following day.

The book is an A4 style folder with a separate page for each day as I had requested at the meeting in August. The Book contains the old records which we were shown at the meeting on the 27<sup>th</sup> August 2019. There is a record for the week ending 25/8/19. This shows that on the Sunday of that week which was Sunday the 25<sup>th</sup> there were only 3 signatures in the record. One of these is Mr Raffiq, who possesses an SIA Licence, one of the others is a legitimate SIA door man and the third is the male manager of Goldies who does not possess an SIA Licence and has wrote "Awaiting badge" in the space for his licence number. This is what Mr Raffiq told us at the meeting on the 27<sup>th</sup> August. Because the 25<sup>th</sup> August 2019 was a Sunday before a Bank holiday he needed to have 3 SIA registered door staff on duty that night from 9pm onwards. I produce copies of those signing in sheets for the week ending 25<sup>th</sup> August as PH/1.

There is a further record for Saturday the 19<sup>th</sup> October 2019 which only has the name of 2 SIA door staff signed in. As this is a Saturday there should be 3 people signed in the book. I

There is a further record for Saturday 7<sup>th</sup> December 2019 which again only has 2 SIA door staff signed in, one of these is Paul Raffiq. This is another Saturday so there should be 3 signatures in the record. I produce this record as PH/3.

My department has been examining CCTV footage at both Goldies and Che Bar in relation to the allegation of the use of an illegal door man. The man has been identified and was pointed out to PC Thorpe and Polly Edwards by Mr Raffiq on his CCTV when they discussed incidents of crime and disorder on 26<sup>th</sup> September 2019. At this time Mr Raffiq again told them the male was his Personal Assistant.

We have since identified lots of footage where this man is clearly operating as a doorman at Che Bar and one occasion where the man appears to be covering the door at Goldies for a half hour period.

There are a number of photos of this man on the Goldies and Che Bar social media posts. He is always dressed in black and stood with other door staff. I produce a selection of these photos as PH/4

Mr Raffiq has provided me with the name of this male and a check with immigration has revealed that the man does not have permission to work in the UK which explains why he does not possess an SIA Licence. I produce an email from Immigration Enforcement Officer Joanne Waller as PH/5

Both Premise Licences are held by Paul RAFFIQ who is also named as the Designated Premise Supervisor (DPS). The premise licence in its current form has been in place since  $30^{th}$  November 2017.

On the 27<sup>th</sup> December 2019 there was an incident at GOLDIES where by a male was ejected from the premises then later died. The two males who had ejected the deceased had previously worked as door supervisors at GOLDIES they are not believed to have been working on the night of the 27<sup>th</sup> December 2019.

On the 28th December I attended GOLDIES and spoke to Paul RAFIQ and the manager RAFIQ informed me that on the night of the 26<sup>th</sup> December 2019 leading into the 27<sup>th</sup> December 2019 he was at work in GOLDIES and that he was acting as a door supervisor and displaying his SIA badge he confirmed that there were three other door supervisors on duty that night one of which was called He also stated that the two males that had ejected the deceased on the 27<sup>th</sup> December 2019 had not worked for him for a couple of weeks.

RAFIQ went onto say that on 27<sup>th</sup> December 2019 while he was present at GOLDIES he noted that that his second premises, CHE BAR, which is situated next door to GOLDIES was busy and that the door staff at the premises needed more support. He sent door supervisor,

Continuation of Statement of Emma Westmoreland to CHE BAR to assist staff there. This meant that there were now a total of three door supervisors on duty at GOLDIES on a busy Boxing Day night. Although this is not a breach of the licence it is not recommended that so few staff are on duty on such a busy night. RAFIQ also stated that he had left the venue prior to the incident on the 27<sup>th</sup> DECEMBER 2019 as a family member was unwell and he needed to care for them.

GOLDIES keep a signing in book which all door staff sign when commencing there shift. Whilst present at Goldies, I seized and retained this book I exhibit it as EEW/2

day and on Friday and Saturday nights, especially at the core times of the Night Time Economy. The premise currently holds a Premise Licence for on and off sales of alcohol until 04:00 hours every day of the week. The closing time for the premise is half an hour after these times.

Goldie's Premise Licence is held by Paul Raffiq who is also named as the Designated Premise Supervisor (DPS). The premise licence in it's current form has been in place since 30<sup>th</sup> November 2017.

In the past 6 months we have had two meetings with Paul Raffiq regarding incidents at Goldie's as well as another premise Mr Raffiq is responsible for. And in two of the meetings door staff levels and the need to have licensed door staff only controlling the doors has been discussed at two of the meetings held over the past year as well as incidents which have occurred in and around the premise.

On Tuesday 27<sup>th</sup> August 2019 at 11:45 hours I had a meeting with Paul Raffiq, also Goldie's manager along with a member of Stockton Borough Council licensing team Polly Edwards (who arrived a little later) and Licensing Sergeant Paul Higgins. We discussed issues around the other premise, but we also discussed issues with door staff levels at Goldie's, how they are recorded and using the same company to cover both venues.

The door staff records did not differentiate between door staff for the two venues so it was impossible to tell what door supervisors were working at which venue and what time they

had started. Some of the sheets were not dated, and some of the door staff details were incomplete. We gave advice that door staff records should be kept separately for both venues with sheets clearly dated, door staff details completed in full and times the door staff were working. These sheets should be kept safe and be available for any responsible authority to review should they request to do so.

Paul Raffiq also told us that on the previous Bank Holiday weekend he only had two door staff on the door to Goldie's as he was unable to source another member of door staff to cover. This was in contravention of his Premise Licence conditions and Paul Raffiq was told this and warned regarding having the correct number of door staff on his venues and that there could be serious consequences should this be breached again. The premise licence under the Annex 2 conditions clearly states:

"A minimum of three (3) SIA registered door staff must be on duty at the premises from 21.00 until closing on a Friday and Saturday night, and a Sunday before a Bank Holiday in order to control the entry of persons to the premises and to keep order in the premises."

Polly Edwards also mentioned information received regarding a possible unlicensed member of door staff. Paul Raffiq stated he knew who we were talking about and that he wasn't door staff but was working for Paul privately not for the clubs and that he was his Personal Assistant. Paul was given advice that he should not have him stood at the door, that by having the male in all black at the doors that would make it appear that he was in fact door staff, and that if he was getting involved in issues normally dealt with by the door

staff that this would also indicate that he was in fact acting as additional door staff. Paul stated he would take steps to rectify this.

A second meeting was held at Che Bar, High Street, Stockton on 2<sup>nd</sup> September 2019 with Polly EDWARDS, council Licensing officer and Paul Raffiq. We discussed variations to the Premises Licence for Che Bar which would clarify the door staff condition and sort out any outdated or duplicitous conditions. Mr Raffiq was happy with what we discussed.

Polly EDWARDS and I also visited Goldie's, High Street, Stockton on 26<sup>th</sup> September 2019 to speak to Mr Raffiq about the conditions he was looking to change in his proposed minor variation to the premise Licence for Che Bar. While we were there Mr Raffiq showed us the CCTV footage quality and the amount of footage held on the system. We also wanted to see if we could spot a male who we had information could be acting as an unlicensed door staff.

On the CCTV footage, we could see a large build, bald headed male dressed in black standing next to Paul Raffiq. Although he was not standing at the door it was clear why people thought he was an unlicensed door supervisor due to his manner and the way he was dressed. We did not see him carrying out any door staff duties while we were watching. Mr Raffiq told us this male was his personal assistant and was definitely NOT a member of the door staff and identified the male by a nick name. It was suggested to Mr Raffiq that the male should not dress in solely black to distinguish him from, the door staff and that the door staff wear a hi-visibility vest or similar to further distinguish them.

Another meeting was held at Middlesbrough Police Office on 10<sup>th</sup> December 2019 with Paul Raffiq (DPS/PLH) and the manager of Goldie's with a Stockton Borough Council Licensing officer, and PC Emma Westmoreland regarding incidents at both of Paul Raffiq's premises. We showed CCTV footage of an incident which occurred on the High Street where a patron from Che Bar, is attacked by a group of males who come from the Yarm Lane end of the High Street. Particular emphasis was given to the number of door staff they will be supplying for the Christmas and New Year period. Raffiq stated he had already implemented Hi-vis body wear to clearly identify the door staff, and that he would be looking to put more door staff on over the busy periods of the Christmas and New Year periods.

I have put together a compilation of Stockton Borough Council CCTV clips which show the unlicensed door supervisor working the doors at both Goldie's and Che Bar, for the most part without Paul Raffig being present. I exhibit this DVD of CCTV clips as AJT/1

Along with PC2463 Westmoreland I have viewed the CCTV footage provided by Stockton Borough Council and we have between us produced tables as a synopsis to the video footage. I exhibit this as AJT/2 for the purposes of this hearing

We have tried to work with the premise and it's Premise Licence Holder and Designated Premise Supervisor Mr Paul Raffiq, but unfortunately the incidents have continued with one of the latest incidents being particularly serious. Reviews are always the last recourse of

- This Licence/Club Registration Certificate is subject to such further conditions as are consistent with any restrictions imposed on the use of the premises for the existing licensable activities under the licence by virtue of the enactments hereinafter set out:-

The Children and Young Person Act 1933
The Cinematograph (Safety) Regulations 1955
The Sporting Events (Control of Alcohol etc) Act 1985

 When door supervisors or other persons carrying out security activities at specified times are employed such individuals must be licensed by the Security Industry Authority.

For the purposes of this condition "security activity" means an activity to which paragraph 2 (1)(a) Schedule 2 to the Private Security Industry Act 2001 applies.

- The admission of children under 18 to the exhibition of any film shall be restricted in accordance with any classification and recommendation in respect of that film made by the British Board of Film Classification or any other film classification body designated under Section 4 of the Video Recording Act 1984.
  - 2. Notwithstanding the above condition a film may be exhibited and children under 18 may be admitted thereto if the permission of Stockton Borough Council is first obtained and any condition of such permission are complied with. For the purpose of this condition the venue operator must submit any film to the council that it intends to exhibit 28 days before it is proposed to show it.
- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-
    - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to -

- (i)drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii)drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2)The designated premise supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
    - (a) a holographic mark, or
    - (b) an ultraviolet feature.
- The responsible person must ensure that -
  - (a) where any of the following alcoholic drinks are sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -
    - (i) beer or cider:1/2 pint;
    - (ii) gin, rum, vodka or whisky:25ml or 35ml; and
    - (iii) still wine in a glass:125 ml;

- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- A. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price
  - B. For the purposes of the condition set out in paragraph A -
    - (a) "duty" is to construed in accordance with the Alcoholic Liquor Duties Act 1979;
    - (b) "permitted price" is the price found by applying the formula -

P=D+(DxV)

Where-

- (i) P is the permitted price
- (ii) D is the amount of duty chargeable in relation to the alcohol as if duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
  - (i) the holder of the premises licence,
  - (ii) the designated premise supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994
- C. Where the permitted price given by Paragraph (b) of paragraph B would (apart from this paragraph)not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny

- D. (1)Sub-paragraph(2)applies where the permitted price given by paragraph (b) of paragraph B on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### **EMBEDDED RESTRICTIONS**

The restriction on the permitted hours for the supply of alcohol shall not prohibit:

- (a) during the first twenty minutes after these hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;

- (g) the taking of alcohol from the premises by a person residing there; or
- (h) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or
- (i) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.
- This licence is subject to such further conditions as are consistent with any restriction imposed on the existing licence of the premises:

For the showing of films under the provisions of the Cinemas Act 1985

and/or

The performance of plays under the Theatres Act 1968

and/or

The provision of public entertainment under the Local Government (Miscellaneous Provisions Act 1982) as below;

- 3. Special Conditions
- 3.1 All doors and windows shall be kept closed whilst entertainment is in progress.
- 3.2 During an event, the licensee (or a suitable representative) shall make subjective assessments, both internally and externally, of the likelihood of noise disturbance being caused by entertainment. The results of these assessments shall be recorded in a logbook including any action required as a result, which shall be retained for one year.

#### **ANNEX 2**

#### CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

#### PREVENTION OF CRIME & DISORDER

 A digital Closed Circuit Television system (CCTV) will be installed and maintained in good working order and be correctly time and date stamped.

The system will incorporate sufficient built-in hard-drive capacity to suit the number of cameras installed, whilst complying with data protection legislation.

CCTV will be capable of providing pictures of evidential quality in all lighting conditions, particularly facial recognition.

Cameras will encompass all ingress and egress to the premises, outside areas and all areas where the sale/supply of alcohol occurs.

There will be a minimum of 14 days recording.

The system will have a minimum of a simplex multiplexing facility and be recording for 24 hours a day.

The system will incorporate a means of transferring images from the hard-drive to a format that can be played back on any desktop computer.

The digital recorder will have the facility to be password protected to prevent unauthorised access, tampering, or deletion of images. There will be at all times a member of staff on duty who is trained in the use of the equipment and upon receipt of a request for footage from a governing body, such as Cleveland Police or any other Responsible Authority, be able to produce the footage within a reasonable time, e.g. 24hrs routine or less if urgently required for investigation of serious crime.

In the event of a technical failure of the CCTV equipment the Premise Licence Holder/DPS must report the failure to Police on contact number 01642 302360 immediately.

- A receptacle disposal bin will be sited to the main access/aggress door to facilitate vessel disposal.
- The DPS and all other members of staff will ensure that no open vessels are taken off the premises by customers.
- A "Challenge 21" policy will be implemented and all staff will insist
  on proof of age from any person appearing to be under 21 years of age
  and who is attempting to buy alcohol. There shall be sufficient
  public notices displayed at the premise to inform customers and remind
  staff that the premise is operating a "Challenge 21" policy.

- An incident book will be kept on the premises at all times. The book will detail in brief, incidents of injury/ejection/refusals/drug misuse/seizure/age challenge. Such matters will be timed, dated and signed by the author and produced to Police and other Responsible Authorities immediately upon request.
- All staff will be fully trained and retrained on a 3 monthly basis in relation to the laws relating to the sale of alcohol to underage persons, persons buying on behalf of under 18's (proxy sales), persons appearing to be under the influence of alcohol and also the operation of the associated "Challenge 21" policy. Staff will receive refresher training at least every 3 months.
- Training records, signed by both the staff member and the Designated Premises Supervisor will be retained for future reference and shall be updated at least every three months. All staff training records will be made available to the Police and other Responsible Authorities on request. All training records must be kept for a minimum of 12 months.
- The maximum permitted occupancy shall be 200 persons.
- The restriction on the permitted hours for the supply of alcohol shall not prohibit the consumption of alcohol during the first 30 minutes after the terminal hour for the supply of alcohol.
- There shall be adequate notices displayed on the premise indicating that the sale of alcohol to those under the age of 18 is illegal and that those adults who buy alcohol for immediate disposal to those under the age of 18 are committing an offence.
- A written drugs policy to the satisfaction of Cleveland Police must be maintained at the premises and a drugs safe must be maintained and emptied regularly.
- A minimum of three (3) SIA registered door staff must be on duty at the premises from 21.00 until closing on a Friday and Saturday night, and a Sunday before a Bank Holiday in order to control the entry of persons to the premises and to keep order in the premises.




- All external doors and windows shall be kept closed when regulated entertainment is being provided except in the event of an emergency.
   Any music played within the premises shall not cause a disturbance at the nearest premises. Any music shall be played indoors only.
- The licence holder or his representative shall conduct periodic assessments of the noise coming from the premises when used for regulated entertainment and shall take steps to reduce the level of noise where it is likely to cause a disturbance to local residents. A written record shall be made of those assessments and shall include, the time and date of the checks, the person making them and the results including any remedial action. All records shall be retained for one year.
- Use appropriate management controls to reduce the likelihood of customers causing noise disturbance to local residents when vacating the premises. This should include placing at all exits from the premises, in a place where they can be seen and easily read by the public, notices requiring customers to leave the premises and the area quietly. (Note, this may also include a reference to vehicles)

### PROTECTION OF CHILDREN FROM HARM

 Children under 18 years shall only be allowed on the premises when food is being served between 11.00 and 15.00.

Goldie's conditions state: A minimum of three (3) SIA registered door staff must be on duty at the premises from 21.00 until closing on a Friday and Saturday night, and a Sunday before a Bank Holiday in order to control the entry of persons to the premises and to keep order in the premises. I have produced a copy of the licence as Exhibit PED1.

Che Bar condition, at the time of our complaints and inspections stated: *A minimum of two SIA door supervisors shall be employed from 21.00 until close Thursday to Sunday inclusive up to 200 patrons plus one additional supervisor per 100 additional patrons thereafter.* I have produced a copy of this licence as Exhibit PED2.

Mr Paul Raffiq is the owner and Designated Premises Supervisor of both premises. I attended the premises on 2 August 2019, straight after this information was received. I attended with my colleague John Wynn, Licensing Officer. Mr Raffiq was at the premises when we arrived and I advised Mr Raffiq of the complaint and the licence conditions relating to the numbers of door supervisors required. He confirmed to me that he does have the right number of door supervisors. We discussed the Che Bar licence and the possibility of changing this by way of a variation. I advised him to have a discussion with Police Licensing initially.

I returned to my office and sent an email to Mr Raffiq to follow up on the visit that day, about the door supervisors and the discussion about a minor variation to the licence at Che Bar to update and improve the conditions imposed on the premises. Mr Raffiq did not reply to this email. I have produced a copy of my email as Exhibit PED3

I spoke with PC Johnson the following week and updated him on my visit and he informed me that Mr Raffiq has been told about this matter of his door staff numbers previously.

On Tuesday 13 August 2019, Ms Donna McCarthy, Licensing Assistant, received a phone call from another local licensee within the town centre. This licensee alleged that there were door supervisors working at Che Bar who are not registered with the Security Industry Authority and two of them should not be working in this country they advised one of the males was waiting for his immigration papers. The licensee was advised to contact Immigration to report this to them. After I received this information I shared it with the Immigration Intel unit for development.

On Tuesday 27 August 2019, I attended a meeting held at Che Bar, with Police Licensing and Mr Paul Raffiq. The meeting was to discuss the death of male over the previous weekend, at Che Bar. It was noted that there was insufficient numbers of Door Supervisors, as per the licence conditions, at Goldies. There should be a minimum of 3 SIA door staff on duty at the premises from 21.00 until closing as it was a Sunday before a Bank Holiday. We were advised that Mr Raffiq and Les were the two working, they advised Kevin was working but Kevin was not, at that time, an SIA registered door supervisor and therefore cannot be counted in to their numbers.

At this meeting I also raised the matter that was reported to us on 13 August 2019 that there was allegedly illegal workers working in his premises. I asked Mr Raffiq if he checks employees Right to Work documents. Mr Raffiq advised all his door supervisors were registered.

On Monday 2 September 2019, I attended another meeting with Police Licensing and Mr Raffiq, this was to discuss the licence at the premises and the proposed variation. The meeting was held in Che Bar.

A further meeting was arranged, by PC Andrew Thorpe so we could finalise the proposed conditions for the minor variation with Mr Raffiq. This meeting took place on Thursday 26 September 2019. PC Thorpe and I met with Mr Raffiq about the minor variation for Che Bar. We met at Goldie's and while there we viewed the CCTV to identify the quality of the footage, the duration it records for and to see the male who had been identified as the unlicensed door supervisor.

On this CCTV footage, the male who had been identified as the unlicensed door supervisor was visible outside Che Bar with Mr Raffiq. Mr Raffiq advised this was Isa, his Personal Assistant. Isa was dressed in all black and is of a large stocky muscular build. I advised Mr Raffiq at this time that perhaps this is why he is getting complaints as it does appear this male is acting as a door person. Mr Raffiq advised me that this is not the case and I then suggested he request Isa does not wear all black, or that he differentiate the door supervisors by way of a high visibility vest or something similar.

At the time of this visit we also spoke to Mr Raffiq about other information that had been received, claiming that someone who is 17 had been served an alcoholic drink in Goldie's and bar staff had advised 'it is ok as she works here'. We met with the female who advised she had not had an alcoholic drink on the premises.

On Friday 27 September 2019, John Wynn and I attended both premises during the evening, after the door supervisors started their duty. Mr Raffiq was outside and the door supervisors were working. We checked the correct number of door supervisors were present and they all had their valid SIA badges on display. We also checked the new signing in sheets for the door supervisors for that week and the previous week.

Is a was there during this visit and we spoke with him. He confirmed to me that he is not a door person and is not acting as such. Mr Raffiq also confirmed this. I explained again about the visual impact to others of how the presence of Isa is coming across and they confirmed he does not act as a door person.


The minor variation paperwork was submitted on Tuesday 22 October and was processed and issued.

During late night enforcement duties on Friday 15 November 2019, John Wynn and I attended Goldie's and Che Bar to speak to Mr Raffiq. His Manageress, Beth, from Che Bar went to get him as he was in the office in Goldie's. Mr Raffiq came outside where we were and his new door supervisor team were in place.

The new Door Supervisor Manager, Neal Jackson, was there and we had discussions about how he is now running the doors in a more improved manner. There was also discussion about the door supervisors now having the black jackets with the high visibility strips on them to differentiate from non-door supervisors.

On Tuesday 10 December 2019, I attended Middlesbrough Police Station for a meeting with Mr Raffiq and Police Licensing to discuss recent events at the premises and to offer advice about the upcoming holiday season and ensuring his compliance with all his conditions. At the meeting Mr Raffiq brought his Managers from Goldie's and Che Bar and Police Licensing showed Mr Raffiq a number of incidents they had from CCTV and raised their concerns over the coming festivities.

On Friday 27 December 2019, I received an email from Sgt Higgins, advising the Licensing Department that someone had died at Goldie's in the early hours of that day. I requested the footage from our CCTV and advised my Team Leader and Manager.

#### **ANNEX 1**

#### MANDATORY CONDITIONS AND EMBEDDED RESTRICTIONS

#### **MANDATORY CONDITIONS**

- No supply of alcohol may be made under the premises licence:
  - (a) at any time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at any time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- This Licence/Club Registration Certificate is subject to such further conditions as are consistent with any restrictions imposed on the use of the premises for the existing licensable activities under the licence by virtue of the enactments hereinafter set out;-

The Children and Young Person Act 1933
The Cinematograph (Safety) Regulations 1955
The Sporting Events (Control of Alcohol etc) Act 1985

 When door supervisors or other persons carrying out security activities at specified times are employed such individuals must be licensed by the Security Industry Authority.

For the purposes of this condition "security activity" means an activity to which paragraph 2 (1)(a) Schedule 2 to the Private Security Industry Act 2001 applies.

- 1. The admission of children under 18 to the exhibition of any film shall be restricted in accordance with any classification and recommendation in respect of that film made by the British Board of Film Classification or any other film classification body designated under Section 4 of the Video Recording Act 1984.
  - 2. Notwithstanding the above condition a film may be exhibited and children under 18 may be admitted thereto if the permission of Stockton Borough Council is first obtained and any condition of such permission are complied with. For the purpose of this condition the venue operator must submit any film to the council that it intends to exhibit 28 days before it is proposed to show it.
- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-
    - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to -

- (i)drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii)drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premise supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
    - (a) a holographic mark, or
    - (b) an ultraviolet feature.
- The responsible person must ensure that -
  - (a) where any of the following alcoholic drinks are sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -
    - (i) beer or cider: 1/2 pint;
    - (ii) gin, rum, vodka or whisky:25ml or 35ml; and
    - (iii) still wine in a glass:125 ml;

- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- A. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price
  - B. For the purposes of the condition set out in paragraph A -
    - (a) "duty" is to construed in accordance with the Alcoholic Liquor Duties Act 1979:
    - (b) "permitted price" is the price found by applying the formula -

P=D+(DxV)

Where-

- (i) P is the permitted price
- (ii) D is the amount of duty chargeable in relation to the alcohol as if duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
  - (i) the holder of the premises licence,
  - (ii) the designated premise supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994
- C. Where the permitted price given by Paragraph (b) of paragraph B would (apart from this paragraph)not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny

- D. (1)Sub-paragraph(2)applies where the permitted price given by paragraph (b) of paragraph B on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### **EMBEDDED RESTRICTIONS**

On Licences
 Permitted Hours

The restriction on the permitted hours for the supply of alcohol shall not prohibit:

- (a) during the first twenty minutes after these hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
- (b) during the first thirty minutes after these hours the consumption of the alcohol on the premises by persons taking meals there if the alcohol was supplied for consumption as ancillary to the meals;
- (c) consumption of the alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises;
- (d) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- (e) the sale of alcohol to a trader or club for the purposes of the trade or club:
- (f) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of member of Her Majesty's Naval, Military or Air Forces;
- (g) the taking of alcohol from the premises by a person residing there; or
- (h) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or
- (i) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.
- This licence is subject to such further conditions as are consistent with any restriction imposed on the existing licence of the premises:

For the showing of films under the provisions of the Cinemas Act 1985

and/or

The performance of plays under the Theatres Act 1968

and/or

The provision of public entertainment under the Local Government (Miscellaneous Provisions Act 1982) as below;

- 3. Special Conditions
- 3.1 All doors and windows shall be kept closed whilst entertainment is in progress.
- 3.2 During an event, the licensee (or a suitable representative) shall make subjective assessments, both internally and externally, of the likelihood of noise disturbance being caused by entertainment. The results of these assessments shall be recorded in a logbook including any action required as a result, which shall be retained for one year.

#### **ANNEX 2**

### CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

#### PREVENTION OF CRIME & DISORDER

 A digital Closed Circuit Television system (CCTV) will be installed and maintained in good working order and be correctly time and date stamped.

The system will incorporate sufficient built-in hard-drive capacity to suit the number of cameras installed, whilst complying with data protection legislation.

CCTV will be capable of providing pictures of evidential quality in all lighting conditions, particularly facial recognition.

Cameras will encompass all ingress and egress to the premises, outside areas and all areas where the sale/supply of alcohol occurs.

There will be a minimum of 14 days recording.

The system will have a minimum of a simplex multiplexing facility and be recording for 24 hours a day.

The system will incorporate a means of transferring images from the hard-drive to a format that can be played back on any desktop computer.

The digital recorder will have the facility to be password protected to prevent unauthorised access, tampering, or deletion of images. There will be at all times a member of staff on duty who is trained in the use of the equipment and upon receipt of a request for footage from a governing body, such as Cleveland Police or any other Responsible Authority, be able to produce the footage within a reasonable time, e.g. 24hrs routine or less if urgently required for investigation of serious crime.

In the event of a technical failure of the CCTV equipment the Premise Licence Holder/DPS must report the failure to Police on contact number 01642 302360 immediately.

- A receptacle disposal bin will be sited to the main access/aggress door to facilitate vessel disposal.
- The DPS and all other members of staff will ensure that no open vessels are taken off the premises by customers.
- A "Challenge 21" policy will be implemented and all staff will insist
  on proof of age from any person appearing to be under 21 years of age
  and who is attempting to buy alcohol. There shall be sufficient
  public notices displayed at the premise to inform customers and remind
  staff that the premise is operating a "Challenge 21" policy.

- An incident book will be kept on the premises at all times. The book will detail in brief, incidents of injury/ejection/refusals/drug misuse/seizure/age challenge. Such matters will be timed, dated and signed by the author and produced to Police and other Responsible Authorities immediately upon request.
- All staff will be fully trained and retrained on a 3 monthly basis in relation to the laws relating to the sale of alcohol to underage persons, persons buying on behalf of under 18's (proxy sales), persons appearing to be under the influence of alcohol and also the operation of the associated "Challenge 21" policy. Staff will receive refresher training at least every 3 months.
- Training records, signed by both the staff member and the Designated Premises Supervisor will be retained for future reference and shall be updated at least every three months. All staff training records will be made available to the Police and other Responsible Authorities on request. All training records must be kept for a minimum of 12 months.
- The maximum permitted occupancy shall be 200 persons.
- The restriction on the permitted hours for the supply of alcohol shall not prohibit the consumption of alcohol during the first 30 minutes after the terminal hour for the supply of alcohol.
- There shall be adequate notices displayed on the premise indicating that the sale of alcohol to those under the age of 18 is illegal and that those adults who buy alcohol for immediate disposal to those under the age of 18 are committing an offence.
- A written drugs policy to the satisfaction of Cleveland Police must be maintained at the premises and a drugs safe must be maintained and emptied regularly.
- A minimum of three (3) SIA registered door staff must be on duty at the premises from 21.00 until closing on a Friday and Saturday night, and a Sunday before a Bank Holiday in order to control the entry of persons to the premises and to keep order in the premises.


#### PREVENTION OF PUBLIC NUISANCE

- All external doors and windows shall be kept closed when regulated entertainment is being provided except in the event of an emergency.
   Any music played within the premises shall not cause a disturbance at the nearest premises. Any music shall be played indoors only.
- The licence holder or his representative shall conduct periodic assessments of the noise coming from the premises when used for regulated entertainment and shall take steps to reduce the level of noise where it is likely to cause a disturbance to local residents. A written record shall be made of those assessments and shall include, the time and date of the checks, the person making them and the results including any remedial action. All records shall be retained for one year.
- Use appropriate management controls to reduce the likelihood of customers causing noise disturbance to local residents when vacating the premises. This should include placing at all exits from the premises, in a place where they can be seen and easily read by the public, notices requiring customers to leave the premises and the area quietly. (Note, this may also include a reference to vehicles)

#### PROTECTION OF CHILDREN FROM HARM

 Children under 18 years shall only be allowed on the premises when food is being served between 11.00 and 15.00.

#### **ANNEX 1**

#### MANDATORY CONDITIONS AND EMBEDDED RESTRICTIONS

#### **MANDATORY CONDITIONS**

- No supply of alcohol may be made under the premises licence:
  - (a) at any time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at any time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- When door supervisors or other persons carrying out security activities at specified times are employed such individuals must be licensed by the Security Industry Authority.

For the purposes of this condition "security activity" means an activity to which paragraph 2 (1)(a) Schedule 2 to the Private Security Industry Act 2001 applies.

- The admission of children under 18 to the exhibition of any film shall be restricted in accordance with any classification and recommendation in respect of that film made by the British Board of Film Classification or any other film classification body designated under Section 4 of the Video Recording Act 1984.
  - 2. Notwithstanding the above condition a film may be exhibited and children under 18 may be admitted thereto if the permission of Stockton Borough Council is first obtained and any condition of such permission are complied with. For the purpose of this condition the venue operator must submit any film to the council that it intends to exhibit 28 days before it is proposed to show it.
- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-
    - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to -
      - (i)drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
      - (ii)drink as much alcohol as possible (whether within a time limit or otherwise);

- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premise supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
    - (a) a holographic mark, or
    - (b) an ultraviolet feature.
- The responsible person must ensure that -
  - (a) where any of the following alcoholic drinks are sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -
    - (i) beer or cider: 1/2 pint;
    - (ii) gin, rum, vodka or whisky:25ml or 35ml; and
    - (iii) still wine in a glass:125 ml;
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol

specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

- A. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price
  - B. For the purposes of the condition set out in paragraph A -
    - (a) "duty" is to construed in accordance with the Alcoholic Liquor Duties Act 1979;
    - (b) "permitted price" is the price found by applying the formula -

P=D+(DxV)

Where-

- (i) P is the permitted price
- (ii) D is the amount of duty chargeable in relation to the alcohol as if duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
  - (i) the holder of the premises licence,
  - (ii) the designated premise supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994
- C. Where the permitted price given by Paragraph (b) of paragraph B would (apart from this paragraph)not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny
- D. (1)Sub-paragraph(2)applies where the permitted price given by paragraph (b) of paragraph B on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax
  - (2) The permitted price which would apply on the first day

applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

- No drink shall be removed from the premises in an unsealed container.
- An incident book shall be maintained at the premises.
- Any person who appears to be intoxicated or behaving disorderly will



I have commented below what I would consider appropriate. You need to look at the condition about no drinks outside. If you wish to have people drinking outside then this would probably be a full variation as you are increasing the licensed area.

I have copied PC Johnson in for his comments too, it could be possible the amendment to the SIA is not covered under a minor and would also be classed as a full. You do not need to do two if a full is required then it can all be done under the full.

I have put all your conditions down below and comments and highlighted where appropriate.

Do not submit the minor variation without discussing with us or Police. Jimmy and I would be happy to come for a visit.

A digital Closed Circuit Television system (CCTV) will be installed and maintained in good working order and be correctly time and date stamped. The Public Health approach to reducing alcohol harm is to encourage and promote responsible drinking and to protect public and children from harm; fundamentally the Public Health approach supports all aspects of promoting the licensing objectives; particularly their link to protecting the health of the Borough and local communities.

Public Health has considered and fully supports the application provided by Cleveland Police to review the premises license at both Che Bar/Goldies Bar, based on the significant, recent and recurring evidence presented for alcohol related harm at both premises.

The current license for Goldies Bar allows for alcohol sales beyond 3am, with Che Bar's license allowing alcohol sales till 3am.

Therefore, the current license at Goldies conflicts with point 134 of the Local Authority's Statement of Licensing Policy (SLP) regarding licensing hours for sale of alcohol as highlighted below: Point 134: In non-residential areas new or variation applications for licences to allow the sale of alcohol or the supply of late night refreshment beyond 3.00am will normally be refused, subject to relevant representations being received.

The above statement is based on local evidence outlining that allowing the sale of alcohol beyond 3am would not be appropriate in Stockton-on-Tees, particularly as the borough is ranked 15<sup>th</sup> nationally for binge drinking. Binge drinking and drinking excessively is linked to high levels of alcohol related harm for the individual and the wider community. A recent survey identified that of those residents who drink, Stockton-on Tees-residents are more likely to drink heavily when they do drink than is the North East average – 26% of people admitted to drinking 10 or more standard drinks when they did drink.

There are many factors that contribute to why adults engage in problematic alcohol consumption such as binge drinking, one of these factors is vertical drinking establishments. Having considered the nature of both premises, Public Health concludes that, in line with point 119 of the SLP that they both operate as vertical drinking establishments. These premises are identified as a particular cause of problematic consumption by the Institute of Alcohol Studies (IAS), which collates evidence about features of the night-time economy that are identified as causes of excessive or problematic alcohol consumption. The IAS describes vertical drinking establishments as those where drinking is an 'end in itself'.

Although the sale of alcohol at Che Bar currently meets the SLP conditions identified above, evidence shows that provision of alcohol up to 3am increases the likelihood of provision of alcohol to individuals who are already drunk allowing for excessive and/or prolonged drinking periods among customers. This increases the likelihood of associated risks and negative outcomes. The sale of alcohol till 3am is also not aligned with what residents felt were appropriate hours of alcohol sales, as highlighted in a survey by the regional alcohol office (Balance) where only 13% of people surveyed within Stockton-on-Tees felt alcohol being sold later than 1am was appropriate. Prolonged and excessive drinking is not conducive to making responsible decisions and the evidence presented by Cleveland Police confirms that this has led to preventable harm to patrons of both premises.

Alcohol can also lower a person's inhibitions, increase risk taking behaviour and impair judgement & decision making processes, which is a cause for concern when considering the availability of cheap drinks deals and offers at the premises. Evidence shows this can further increase the likelihood of such risks outlined above occurring and can be reasonably assumed to be a contributory factor regarding the incidents that have taken place, especially when combined with late alcohol sales.

Regarding Points 28 & 29 of the (SLP) which refer to the Crime Survey for England and Wales (Office for National Statistics in 2014), the survey highlights a strong link between alcohol and violence. It reports 53% of all violent incidents being alcohol related, 36% of domestic violence incidents were alcohol related, and of the violent incidents reported between 10.00pm and 6.00am, over 80% involved alcohol. Evidence shows that even a minimal increase in hours of alcohol sales has a significant impact on levels of crime and disorder and subsequently the need for additional enforcement which has wider implications on public safety – which is clearly evident when considering the incidents that have taken place at the premises.

A recent study from Balance also linked the increasing availability to an increase in physical assaults associated with alcohol consumption. This evidence is wholly relevant when considered locally, as within Stockton Borough there is a rate of 3.53 alcohol related violent crimes per 1,000 people per year, which is higher than the regional rate of 2.84 per year. In addition, there is evidence that repeat incidences of domestic abuse are high in Stockton-on-Tees (Stockton-on-Tees Domestic Abuse Strategy).

It is also crucial to acknowledge that the ward in which Goldies Bar/Che Bar is situated (Stockton Town Centre) is ranked worst in the Borough for all of the following datasets. This provides further cause for concern around the issues highlighted above regarding excessive levels of alcohol

consumption and associated alcohol related harm, crime and disorder.

- Outlet density
- Hospital stays for alcohol related harm
- All crime under the influence of alcohol
- Violent crime under the influence of alcohol
- Admissions wholly attributable to alcohol
- Admissions partially attributable to alcohol
- Hospital admissions for self harm
- Rates of reported domestic abuse

In context of the evidence, local alcohol related harm and current issues at Goldies/Che Bar outlined in statements provided by Cleveland Police - Public Health feels that both premises undermine the SLP licensing objectives of Public Safety, Crime and Disorder and Public Nuisance.

Therefore, Public Health supports the application for a review to the premises license and recommends conditions be put in place to mitigate the potential for further alcohol related harm to take place at both premises. In particular, we would support implementing a reduction in the hours of alcohol sales and a Minimum Unit Price (MUP) condition to reduce the availability of cheap alcohol to already intoxicated individuals, subsequently lowering the risk of further alcohol related harm, crime and disorder.
