Stockton-On-Tees Licensing Service are working towards an effective and robust licensing regime and the promotion of the four licensing objectives. The Licensing Service has a primary role in the

administration and compliance of the Licensing Act 2003.

Mr Gary Cooke is the Premise Licence Holder (PLH) and Designated Premise Supervisor (DPS) at the Penny Black. Members of public have contacted the Licensing Service independently detailing concerns about incidents at the premises and the behaviour of Mr Cooke. All the residents involved have asked to remain anonymous and will not make representations in person for fear of repercussions for themselves or their families. They all live in very close proximity to the premise and some have had negative experiences including intimidation when raising issues directly with Mr Cooke or other staff at the premise.

The licensing authority have no reason to believe any of the information provided by residents is frivolous or vexatious. All the residents are in support of the Polices application to review the premise licence and have asked that I include their information in this representation.

I attach copies of emails which have been anonymised as LMK1, LMK2 and LMK3.

In addition to emails, phone calls have been received by an anonymous resident who lives very close to the premises, I will refer to as resident 4.

On the 03 August 2020 notes taken at the time of the call detail:

Kids dancing on tables and plying loud music till 1:30 in the morning on weekends, this has been going on since premises could reopen.

Phoned security centre was told close at 10:00pm to call the Police, called the Police was told no officers available or could not do anything till kicking out time.

Called the premises and asked for the music to be turned down only lasted about 20 minutes then came back on.

Also laughing gas canisters on premises, and they are posing videos/photos on social media of being at the premises at 1:30 in the morning.

They are 19 – 20-year old's in cars on the car park and in front of the premises.

Anon resident called me again on 14 August 2020 notes taken at the time of the call detail:

Drug taking and dealing taking place at the premises, landlord lives on the premises and he is having "stoppy backs" until 7am, there is fighting on the premises and outside the premises spilling over onto residential properties with males from the premises ending up in residents gardens and leaving bottles / pint glasses on walls.

Again, anon resident 1 called me on 23 September 2020 notes from the call detail:

Nothing has changed at the premises even though they are under review, Mr Cooke is advising his customers that his solicitor has told him there is nothing to worry about, there is still drug taking and dealing taking place on the premises, with people entering the premises round the back from the car park for "stoppy backs" so they cannot be seen in the front bar.

After receiving an email from a resident on the 13 August 2020 I checked www.tripadvisor.co.uk and searched for Penny Black Stockton, the premise is featured on the website and I attach recent reviews of the premises as LMK4.

On the 20 August 2020 I received a screen shot photograph of a Instagram message allegedly from the Chef at the Penny Black advising his Instagram followers measures were being put in place at the premises to keep Police and licensing "sweet", and that "normal service will resume soon" I attach a copy of this photograph as LMK5.

On the 3 September 2020 a complaint was sent to Matthew Vickers MP from a resident, I attach a copy of this complaint as LMK6

On the 28 September 2020 I had a phone call with resident 5 notes taken at the time of the call from detail:

We have lived close to the premise for 27 years and never had problems like this, smashed glasses and bottles and silver laughing gas cannisters in the road, its dangerous when walking dogs, we know we live near to a pub and to expect some noise especially at Christmas but what is happening now is "out of order, not right".

In each case I replied to the residents and the above information was shared with the Police who

confirmed they were looking into the complaints and trying to engage with Mr Cooke and trying to view CCTV at the premises. In response to the complaints Licensing Officers visited the premises and statements detailing this are attached.

The Licensing Service received the application to review the premises licence from Cleveland Police on 4 September 2020, Officers put the review notices up at the premises on the 4 September 2020 and spoke to PLH / DPS Gary Cooke explaining the process and the possible options open to the Licensing Committee. This representation shows the same residents, contacting the Licensing Service before and after Mr Cooke received notification of review.

As PLH / DPS Mr Cooke holds full responsibility for the premises, allowing this behaviour on the premises and by those leaving the premises suggests a serious failure to understand the management of the premises, and as such his behaviour undermines the prevention of Crime And Disorder Objective and Public Nuisance Objective. To compound matters previous warnings, visits and advice given to Mr Cooke by the Licensing Service and Police have failed to address and prevent a repetition of the behaviour.

The Licensing Authority must have regard to the licensing objectives outlined, the legislation supports protecting the public and local residents from crime, anti-social behaviour and noise nuisance caused by irresponsible licensed premises. The recent complaints and concerns raised by residents are relevant to this review. This representation is, therefore, submitted on behalf of the Licensing Authority with responsibility for the administration of, and compliance with, The Licensing Act 2003 and in support of the Polices application to review the Penny Black premise licence.

Hello.

I live three streets away from 'The Penny Black' in Hartburn and since the re-opening of pubs on 5th July there has been shouting and screeching till 1am from there every Friday and Saturday night. On top of this there is smashed glass all the way down Ellerton Road with pint glasses just left on the roadside. There is also silver gas cannisters littered around. With having a young family myself, this is dangerous and extremely concerning addressing now before anyone, or even dogs infact, hurt themselves. Cars are racing in and out of the car park, speeding round the corners and down the road. These seem to be driven by young males. Again, very worrying as a resident in the area with young children.

I've seen videos of violence within the pub and have seen crowds of youths congregating inside and outside. This pub never attracted such young people before lockdown which would make me question what is going on in there and how many are actually of legal drinking age. You can see people playing pool and on the gambling machines which is not allowed. The lack of social distancing is extremely worrying and I feel very aggrieved this is allowed to happen when the majority of us have, and still are continuing to act sensibly and safely, but having this on our doorstep could pose a huge risk to us and our families. Throughout lockdown the pub seemed to create their own rules in regards to who they had in, despite the Government stating they could not open.

Interestingly, recent TripAdvisor reviews support what we have witnessed too. I don't feel safe in my home area due to the anti-social behaviour and major lack of social distancing. This needs investigating by the council ASAP and would appreciate a response to this complaint.

Please take these licenses away from this pub let the brewery get somone who can run the pub as a residential one as it was when we moved here when it was a family peaceful pub with no problems.



see that the television was on. I did see 1 of the males take a drink from a pint glass but I could not identify the contents of the glass.

At 20:40 on 25th April 2020. I again went to the Penny Black and I parked outside facing the front bar. I could see that the lights were on, but the blinds were closed. I noticed a sign on the left-hand side of the entrance which was advertising take-away food from 12 – 7.

At 21:10 on 9th May 2020, I returned to the Penny Black and again parked outside. The lights were on and the blinds open and I could clearly see 4 males in the front bar of the premise. I also noticed that take-away food hours had been increased from 12 – 9. This information was shared with Police and Environmental Health Service and a prohibition notice was issued by Environmental Health on 19th May 2020.

At 17:10 on 5th July 2020, I went to the Penny Black accompanied by my colleague Kirsty WANNOP. I observed that customers were sat outside the premise on benches and inside the premise. At that time everyone was social distancing and it was quiet.

At 21:35 On 31st July 2020, I again attended the Penny Black accompanied by my colleague Polly EDWARDS. As I drove into the car park, I could hear very loud music being played from vehicles parked in the car park. There were approximately 40-50 people in the beer garden and car park, and they were not social distancing. I looked into the front bar which was packed with mainly young people none of whom were social distancing and were dancing and mixing in large groups

At 20:55 on 15th August 2020, I attended the Penny Black accompanied by Kirsty WANNOP. There was no loud music this time however in the car park and beer garden there was approximately 30 people none of whom were social distancing and were talking and shouting. Again, the front bar was packed with young people and no social distancing was taking place. I witnessed what appeared to be a drug deal taking place in front of me. A customer who had been standing outside the premise

approached a VW Golf which had just driven into the car park. An exchange took place between him and the driver. The customer handed the driver a single £20 note and in return he received a small clear packet. They shook hands and the VW Golf left. I reported the vehicle details to Cleveland Police.

On 17th August 2020, I contacted Flint Bishop LLP who act for the brewery who rent the Penny Black to the premise licence holder Mr Gary COOKE. The was aware Police were speaking to Mr Cooke and that Police were having problems contacting someone from the brewery and I wished to give the details of my observations the previous Saturday night and hopefully prevent a reoccurrence. I submitted my concerns regarding the premise on the brewery on-line portal. I stated that I had witnessed a total lack of social distancing at the premise and the generally disorderly conduct going on. I also mentioned the drug deal that I had witnessed. I pointed out that residents' lives were being affected. Later that day I received an e-mail from Mr Gui CHIPCHASE who is the Licensing Manager for Flint Bishop LLP.

He stated that as Mr Gary COOKE is a tenant at The Penny Black, we should speak to him he also stated that he had forwarded my e-mail to the district manager for the brewery along with the latest government guidance. I replied and stated that I would await the possible premise licence review by Cleveland Police. I received an acknowledgement from him a short time later. I attach a copy of these emails as JW1.

Since the 4th July 2020, I have spoken to several residents who contacted the licensing service and who live in the area of the premise. They have all reported the anti-social behaviour and noise of customers on mainly Friday and Saturday nights. They all wished to remain anonymous due to fear of reprisals.

At 18:05 on 4th September 2020, I attended the Penny Black accompanied by my colleague Polly EDWARDS. The reason for the visit was to display the blue notices which gave details of the premise licence review submitted by Cleveland Police. I

I returned that same night around 22:10 in order to further ensure compliance. I parked away from the premises and observed for a few minutes. I could see 4 people, it appeared to be 3 males and 1 female. The blinds were open and those inside were playing pool. The TV was on. I fed this information back to my superiors and Police Licensing as part of my update, as I know the Police were keen to ascertain any breaches with the Covid regulations.

Saturday 2 May 2020, I attended the Penny Black, Langthorne Grove, Hartburn at around 19:50. I again saw a couple of people inside but was unable to identify them. There was a sign outside saying open for take away, but I could not see anyone else inside. I fed this information back to my superiors and Police Licensing as part of my update.

Saturday 4 July 2020, I worked with my colleague Mrs Sandra Percival as the restrictions on the hospitality industry relaxed. At around 18:30, we checked the Penny Black and there was a lot of people outside, socially distanced, sitting at tables around the beer garden and car park. We did not stay or speak with anyone, we observed and left. Mr Gary Cooke, PLH and DPS did come out of the premises, as we were leaving, so he was aware that we had been to observe, I saw him speaking with customers and heard 'Was that Licensing'.

Friday 31 July 2020, myself and my colleague Mr John Wynn attended the Penny Black at approximately 21.35. We stayed in our vehicles and observed. There were a lot of patrons, mainly younger people. I observed no social distancing inside or outside of the building, dancing inside and loud music could be heard outside. The beer garden / decking area people were close together, less than 2 metres. I fed this information back to my superiors and Police Licensing as part of my update.

Friday 21 August 2020, I attended the premises with my colleague Mr Michael Fearman, Environmental Health Officer, at approximately 20.10. We walked past the front of the premises on the main road, there were about 10 young males in the car

park chatting, loud but not excessive. We then walked up the road and turned around and walked back past, the males had gone. There were other males in the far edge of the car park, I could not hear talking or music. The premise was quiet. The TV was on hardly any people inside. We then walked away and came back at around 20.30 again the premise was quiet. I fed this information back to my superiors and Police Licensing as part of my update.

That same evening at around 21.25 I drove passed the premises, I observed two people inside, plus the licensee. The TV was still on. No noise could be heard.

I kept feeding this information into updates which were shared with Police Licensing who I knew were in contact with Mr Cooke and they had advised they were submitting an application to review the premise licence.

On Friday 4 September 2020, John Wynn and I attended the premises to erect the notices for the review. We arrived around 18:30. We went into the premises and spoke with a female with dark hair, I believe to be Mr Cooke's partner. I asked if he was available. I had called earlier to advise we would be attending so he was expecting us. She confirmed he would be down shortly.

We met with Mr Gary Cooke, the licensee, in the dining / lounge area of the premises. I explained why we were there, then we had a conversation about the premises and how Mr Cooke has been handling lockdown etc. I asked Mr Cooke how things were since reopening and how was he managing Social Distancing and he said, 'Yes, fine.'

There were a few people in the dining / music side of the premises, seated. The bar area was reasonably busy, not excessive, however there did not seem to be much social distancing with the customers. When John and I were speaking with Mr Cooke, at the front entrance while placing a notice on the main front door, one of the customers came along, shook hands with Mr Cooke and went inside.
