LICENSING ACT 2003
APPLICATION FOR VARIATION OF A PREMISE LICENCE
HERON FOODS – 11 REDHILL ROAD, STOCKTON

SUMMARY

The purpose of this report is for Members to determine an application for the variation of a premise licence under the Licensing Act 2003 to which there have been representations from individual residents, a residents group, and a Councillor.

RECOMMENDATION

That Members determine the application.

THE APPLICATION

1. An application for the variation of a Premise Licence has been received from Heron Foods LTD, in relation to Heron Foods, 11 Redhill Road, Stockton. The variation is to increase the supply of alcohol hours from Monday to Saturday 08:00-20:00 Sunday 10:00-16:00 to Monday-Saturday 07:00-22:00 and Sunday 08:00-20:00 A copy of the application is attached at Appendix 1.

RESPONSIBLE AUTHORITIES

2. Representations have been received from individual residents, a residents group and a Councillor in relation to Prevention of Crime and Disorder, Prevention of Public Nuisance, Protection of Children from Harm and Public Safety. Copies of the representations are attached at Appendix 2.

3. A Google street map and ariel view, showing the location of the premises, is attached at Appendix 3.

LEGISLATION AND POLICY CONSIDERATIONS

5. **Current Council Policy states:**

> 'The Council recommends that applicants risk assess their operation against the four licensing objectives to identify potential areas of concern. An operating schedule should include information which is necessary to enable any responsible authority or other person to assess whether the steps to be taken to promote the licensing objectives are satisfactory.' Pg 9.

> Shops, stores and supermarkets will in general be licensed to provide sales of alcohol for consumption off the premises at any time when the retail outlet is open for shopping but new or variation applications requesting that the sale of alcohol starts before 9.00am or finishes after 10.00pm in residential areas will generally be refused. In addition, new or variation applications for the supply of alcohol for consumption on the premises before 9.00am or after 11.30pm (12 midnight on a Friday and Saturday night) in residential areas will normally be refused.

> New or variation applications for late night refreshment in terms of hot food takeaways in residential areas will normally be refused beyond 12 midnight. Pg 22.

MEMBERS OPTIONS

- 6. Members must carry out their functions with a view to promoting the four licensing objectives:
 - The prevention of crime and disorder
 - Public safety
 - The prevention of public nuisance
 - The protection of children from harm

Members may consider the following options:

- 1. To refuse the application.
- 2. To grant all or part of the application subject to the necessary conditions to promote the four licensing objectives.
