All quizzes have a pass rate of 100% with the exception of the final assessment which is 90%.

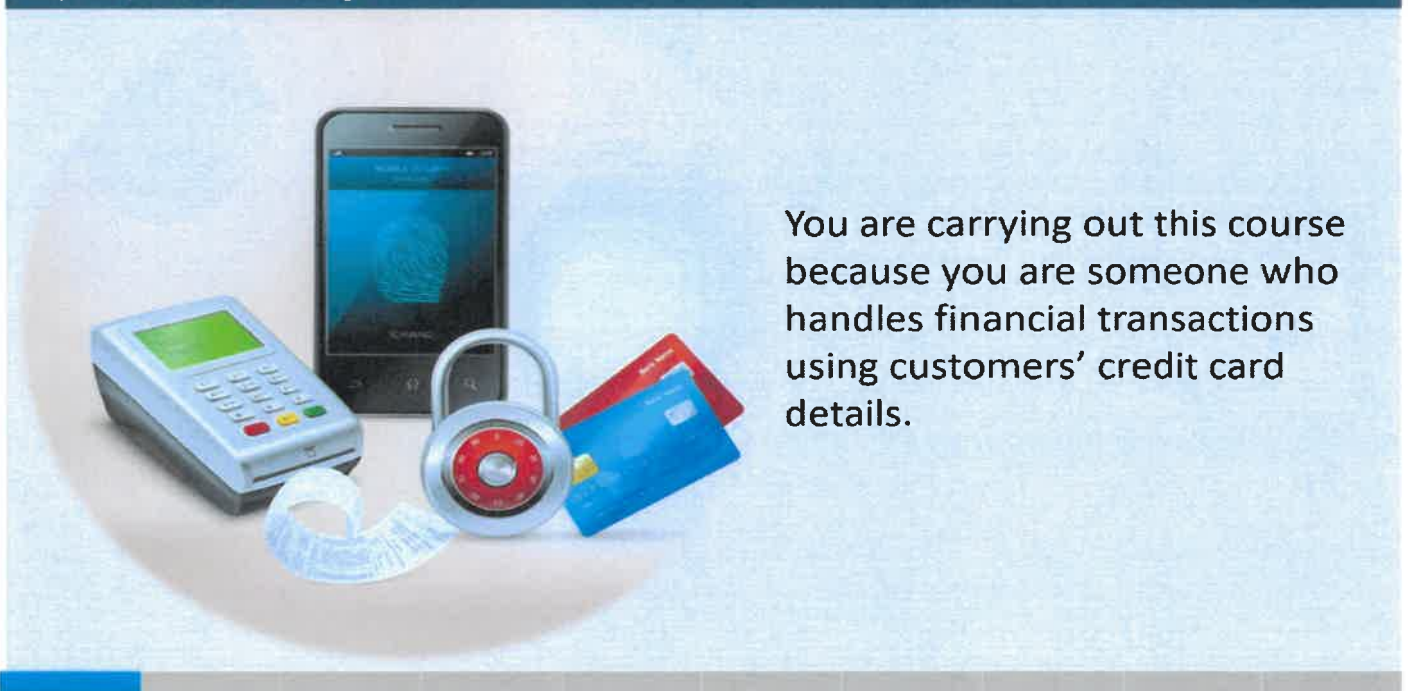
