

### **Table 1 - Disclosable Pecuniary Interests**

Subject	Description
Employment, office, trade, profession or vocation	Any employment, office, trade, profession or vocation carried on for profit or gain
Sponsorship	Any payment or provision of any other financial benefit (other than from the council) made to the councillor during the previous 12-month period for expenses incurred by him/her in carrying out his/her duties as a councillor, or towards his/her election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.
Contracts	Any contract made between the councillor or his/her spouse or civil partner or the person with whom the councillor is living as if they were spouses/civil partners (or a firm in which such person is a partner, or an incorporated body of which such person is a director* or a body that such person has a beneficial interest in the securities of*) and the council
Contracts	<ul> <li>(a) under which goods or services are to be provided or works are to be executed; and</li> <li>(b) which has not been fully discharged.</li> </ul>
Land and property	Any beneficial interest in land which is within the area of the council. 'Land' excludes an easement, servitude, interest or right in or over land which does not give the councillor or his/her spouse or civil partner or the person with whom the councillor is living as if they were spouses/ civil partners (alone or jointly with another) a right to occupy or to receive income.
Licences	Any licence (alone or jointly with others) to occupy land in the area of the council for a month or longer.
Corporate tenancies	Any tenancy where (to the councillor's knowledge)— (a) the landlord is the council; and (b) the tenant is a body that the councillor, or his/her spouse or civil partner or the person with whom the councillor is living as if they were spouses/ civil partners is a partner of or a director* of or has a beneficial interest in the securities* of.
Securities	Any beneficial interest in securities* of a body where— (a) that body (to the councillor's knowledge) has a place of business or land in the area of the council; and (b) either— (i) the total nominal value of the securities* exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the councillor, or his/ her spouse or civil partner or the person with whom the councillor is living as if they were spouses/civil partners have a beneficial interest exceeds one hundredth of the total issued share capital of that class.

\* 'director' includes a member of the committee of management of an industrial and provident society.

\* 'securities' means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.



## Table 2 – Other Registerable Interest

You must register as an Other Registrable Interest:

a) any unpaid directorships

b) any body of which you are a member or are in a position of general control or management and to which you are nominated or appointed by your authority

- c) any body
- (i) exercising functions of a public nature
- (ii) directed to charitable purposes or

(iii) one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union) of which you are a member or in a position of general control or management

#### SHA/1122/ Evacuation Procedure

The Evacuation Procedure Agenda item had been added in error and was not necessary for Stockton Home Safety Association.

#### SHA/1222/ Declarations of Interest

There were no Declarations of Interest.

#### SHA/1322/ Minutes

Consideration was given to the minutes of the meeting held on 11<sup>th</sup> July 2023.

AGREED that the minutes of the meeting held on 11<sup>th</sup> July 2023 be approved.

#### SHA/1422/ Campaign Topics

Campaign Topics put forward by Members and Officers were as follows:

- To highlight the dangers of copies or imitation children's toys, as they don't meet the same safety standards as genuine items.
- The dangers of button batteries for children and how they can be often found in toys.
- How to properly use Christmas lights, for example not overloading electrical sockets when decorating.

Members also mentioned if anything could be included around the increase in Electric Scooters used in Stockton. But it was noted that the issues around Electric Scooters would be a Policing matter and legislation.

#### SHA/1522/ Report of The Trading Standards Officer

Officers gave a verbal update to Members; Officers were hopeful that a new licensing scheme would be brought into deal with the increase in Botox and other filler products being sold and used in treatments.

Trading Standards would be taking part in a consultation on Furniture and the associated Safety Regulations, which Officers informed members hadn't been updated since the 1980's.

Another consultation around the possible banning of Vapes would also be taking place. Members expressed their support of such a ban as members of the public had been coming to them for years highlighting their concerns around vape usage and especially with their use by Children.

Trading Standards Officers did note that if a ban came into place Vapes would become illicit products which could be much harder to take off shelves.

Agreed that the update be noted.

#### SHA/1622/ Report of The Home Safety Officer- Children's Services

The Family Safety Sessions which Officers continue to hold had remained popular with the public and Foster Carers and potential Foster Parents. After School Health Clubs for Kids were still being held and would be held over the half terms.

A Winter noticeboard had been displayed at these events highlighting, Hot water bottle usage safety, Electric Blanket Safety and Christmas light safety. Work would be carried out to promote the National Burns Day to raise awareness to the public.

Officers would bring to the next meeting a report that would outline the various categories that made up Accident & Emergency admissions for 2021 & 2022.

Agreed that the update be noted.

#### SHA/1722/ Report of The One Call Officer

The One Call Officer had sent their apologies for the meeting while supplying a brief update on response time data.

Members were pleased by the data which showed good response times to the public's calls.

Agreed the Update be noted.


