Table 1 - Disclosable Pecuniary Interests

Subject	Description
Employment, office, trade, profession or vocation	Any employment, office, trade, profession or vocation carried on for profit or gain
Sponsorship	Any payment or provision of any other financial benefit (other than from the council) made to the councillor during the previous 12-month period for expenses incurred by him/her in carrying out his/her duties as a councillor, or towards his/her election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.
Contracts	Any contract made between the councillor or his/her spouse or civil partner or the person with whom the councillor is living as if they were spouses/civil partners (or a firm in which such person is a partner, or an incorporated body of which such person is a director* or a body that such person has a beneficial interest in the securities of*) and the council — (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.
Land and property	Any beneficial interest in land which is within the area of the council. 'Land' excludes an easement, servitude, interest or right in or over land which does not give the councillor or his/her spouse or civil partner or the person with whom the councillor is living as if they were spouses/ civil partners (alone or jointly with another) a right to occupy or to receive income.
Licences	Any licence (alone or jointly with others) to occupy land in the area of the council for a month or longer.
Corporate tenancies	Any tenancy where (to the councillor's knowledge)— (a) the landlord is the council; and (b) the tenant is a body that the councillor, or his/her spouse or civil partner or the person with whom the councillor is living as if they were spouses/ civil partners is a partner of or a director* of or has a beneficial interest in the securities* of.
Securities	Any beneficial interest in securities* of a body where— (a) that body (to the councillor's knowledge) has a place of business or land in the area of the council; and (b) either— (i) the total nominal value of the securities* exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the councillor, or his/ her spouse or civil partner or the person with whom the councillor is living as if they were spouses/civil partners have a beneficial interest exceeds one hundredth of the total issued share capital of that class.

* 'director' includes a member of the committee of management of an industrial and provident society.

* 'securities' means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

14/22** **LICENSING ACT 2003
APPLICATION FOR VARIATION OF A PREMISES LICENCE
THE VANE ARMS – DURHAM ROAD, THORPE THEWLES**

Members of the Statutory Licensing Sub Committee of the Councils Statutory Licensing Committee were asked to consider an application for a variation of a premise licence for Then Vane Arms - Durham Road, Thorpe Thewles, Stockton on Tees, where a number of objections had been received from local residents.

The Chair introduced all persons who were present and explained the procedure to be followed during the hearing.

A copy of the report and supporting documents had been provided to all persons present and to Members of the Committee.

Members of the Statutory Licensing Sub Committee of the Council's Statutory Licensing Committee considered the above variation application, full details of which appeared before Members in their committee papers.

The Applicants legal representative Mr Richard Arnot informed the Sub-Committee that he was representing the company in their application to vary a premises licence.

Mr Arnot highlighted the case of Taylor v Manchester City Council TCG Bars Ltd [2012] EWHC 3467 (Admin), which the Sub-Committee heard was the leading case law in relation to variation applications.

Mr Arnot also gave the Sub-Committee an overview of the premise and its business; it was 70% food-led and employed 18 members of staff. Mr Arnot pointed the Sub-Committee to Director, Mr Ben Icke's, CV, and the positive reviews of the premises within the papers before the Sub-Committee.

Mr Arnot summarised his client's application to the Sub-Committee: -

- To extend the area licenced for the sale of alcohol to include the conservatory area, small function area and the outside area, as detailed within the supplied plan, in order to enable staff to take orders/payments outside.
- To remove the condition under which children have to leave the premises by 19:00 hours, in order to be more family-friendly; and
- To extend the time period for the supply of alcohol to begin at 10:00 hours and end at 23:00 hours, Monday to Saturday, and 10:00 hours to 22:00 hours on Sunday. Mr Arnot highlighted that the Council had recommended that thirty minutes be added to the premises' closure times (23:30 hours Monday to Saturday and 22:30 hours on Sunday) as this was preferred by the Council to assist with the gradual dispersal of patrons.

The Sub-Committee heard from Mr Arnot that Mr Icke had sought to engage and work with local residents, which was confirmed within the Licensing Officers report. Mr Arnot explained that the proposed conditions that his client had agreed with Environmental Health sought to address residents' concerns around noise, including the external area being limited to use from 10:00 hours to 22:00 hours.

Having been asked a question in relation to child safeguarding, Mr Arnot confirmed to the Sub-Committee that in relation to the condition under which children had to leave the premises by 19:00 hours, the application was to be amended to change this condition, rather than remove it. The application therefore was to amend the time from 19:00 hours to 21:00 hours within this condition.

Residents were given an opportunity to ask questions of the applicant. The members of the Sub-Committee asked questions of the applicant.

It was noted that Environmental Health had made representations however these were later withdrawn once conditions were agreed. The applicant had indicated amendments to their operating schedule which would be attached by way of conditions should the variation application be granted. A copy of the conditions agreed with the applicant was appended with the main report.

Members had regard to the twelve representations received from residents of Thorpe Thewles, the majority of whom had rear gardens adjacent to the rear garden of the premises.

The Sub-Committee heard from residents that their main concerns arose from the proximity of the premises to their gardens, particularly in relation to noise emanating from the raised decked area within the premises' garden. The Sub-Committee were told that other concerns included patrons of the premises looking into their properties, and residents feeling reluctant to enjoy their gardens due to patrons of the premises being heard talking nearby.

One resident referred to the noise from children playing football, however accepted that this was no longer an issue since the applicant removed football goals from the premises' garden. The residents expressed to the Sub-Committee that they felt that their quality of life was suffering as a result of the issues outlined to the Sub-Committee.

The Sub-Committee heard from residents in relation to concerns that appeared to be planning matters. The Chair of the Sub-Committee explained to everyone present that licensing and planning were separate regimes that operated independently.

The members of the Sub-Committee and other parties were given an opportunity to ask questions.

All parties present were given an opportunity to sum up their case with the applicant invited to speak last.

Members had regard to all of the Sub-Committee papers, which had been circulated prior to the hearing and presented to them, in addition to the oral submissions made on behalf of the applicant and the other parties at the meeting.

Having carefully considered those matters brought before them and in reaching their decision, the Members had full regard to both the provisions of the Licensing Act 2003 (as amended by the Violent Crime Reduction Act 2006), the Guidance Issued under Section 182 of the Licensing Act 2003 (as amended), the Council's Licensing Policy, and the case law highlighted by the applicant's representative.

The Sub-Committee noted that conditions had been agreed between the applicant and responsible authority Environmental Health. The Sub-Committee were of the view that they had to give weight to the fact that the relevant appropriate authority had considered the application and was of the view that the proposed conditions would ensure that the premises would not undermine the licensing objectives. The conditions sought to address the concerns which had been expressed by residents who had objected to the application.

The Sub-Committee noted Mr Icke's engagement with the premises' neighbours and local residents. The Sub-Committee were satisfied that the applicants understood their responsibilities and would continue to operate the premises in a responsible manner and respond proactively to complaints.

The Sub-Committee noted that the residents who had objected to the application were concerned at the potential for noise nuisance. The Sub-Committee also noted that they must consider this application for a variation of the premises licence on its own merits. The Sub-Committee were mindful that an application could not be refused based solely on the residents' concerns before them. On balance it appeared to the Sub-Committee that the proposed conditions would ensure that residents were not subject to public nuisance and that the licensing objectives would not be undermined.

After considering all of the evidence and representations, the Sub-Committee were of the view that the application could be granted, subject to the amendment agreed by Mr Arnot regarding the condition under which children must leave the premises by 21:00 hours, and the inclusion of the nine conditions agreed between the applicant and Environmental Health.

The Sub-Committee granted the variation application with the following hours:-

Licensable activities including the supply of alcohol were granted as set out in the application:

Monday to Saturday 10:00 to 23:00 hours.
Sunday 10:00 to 22:00 hours.

Hours premises are open to the public Monday to Friday with a closing time of 23:30 hours and Sunday 22:30 hours.

Amended condition - Children will not be allowed in the pub after 21:00 hours unless they are dining and accompanied by an adult (formerly 19:00 hours).

As well as conditions as detailed in the operating schedule the Sub-Committee also attached the following additional conditions to the Premises Licence:-

Conditions agreed with Environmental Health

1. All external doors and windows shall be kept closed (excluding for access and egress) while entertainment is in progress.
2. The use of the external area by customers shall be limited from 10:00 to 22:00 hours.
3. Noise from the premises shall not cause a public nuisance at any residential property in the vicinity.
4. Any music played in the premises after 23:00 hours should be background music only.
5. Refuse, including bottles shall be disposed of from the premises between the hours of 07:00 - 18:00 hours.
6. The licence holder or his representative shall conduct periodic assessments

of the noise coming from the premises and shall take steps to reduce the level of noise where it is likely to cause a disturbance to local residents. A written record shall be made of those assessments and shall include, the time and date of the checks, the person making them and the results including any remedial action. All records shall be retained for one year.

7. Use appropriate management controls to reduce the likelihood of customers causing a nuisance to local residents when using and vacating the premises. This should include placing at all exits from the premises, in a place where they can be seen and easily read by the public, notices requiring customers to use and leave the premises and the area quietly. (Note, this may also include a reference to vehicles).

8. There shall be no use of lighting likely to cause a nuisance to local residential properties.

9. All deliveries/collections associated with the business activity should be undertaken in ways which will not cause a noise disturbance to local residents.

RESOLVED that the application for grant of a Variation of a Premise Licence for The Vane Arms, Durham Road, Thorpe Thewles, Stockton on Tees, be granted for the reasons as detailed above.

SUMMARY

The purpose of this report is for Members to consider an application for a review of a premises licence from the Licensing Service on the grounds of the prevention of crime and disorder and public safety objectives.

MEMBERS OPTIONS

9. Members are advised that under the provisions of Section 51(4) The Licensing Act 2003 the authority may, at any time, reject any ground for review if it is satisfied –
- that the ground is not relevant to one or more of the licensing objectives, or
 - in the case of an application made by a person other than a responsible authority, that-
 - the ground is frivolous or vexatious, or
 - the ground is a repetition
10. If Members are not minded to reject this application, then under the provisions of Section 52(3) The Licensing Act 2003, the authority must, having regard to the application and any relevant representations take such steps mentioned in subsection (4) (if any) as it considers necessary for the promotion of the four licensing objectives. The steps are –
- a) to modify the conditions of the licence which could include reducing opening hours or requiring door supervisors at a particular time;
 - b) to exclude a licensable activity from the scope of the licence;
 - c) to remove the designated premise supervisor for example, because they consider that the problems are the result of poor management;
 - d) to suspend the licence for a period not exceeding three months;
 - e) to revoke the licence
 - f) and for this purpose, the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.

Where the authority takes a step mentioned in (a) or (b), it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.

11. The Committee also have the option to leave the licence in its existing state.

As a Responsible Authority under the Licensing Act 2003 I represent licensing at Stockton-on-Tees Borough Council. I apply for a review of the premises licence for Premier Mini Market 75-81 Oxbridge Lane, due to the undermining of the licensing objectives:

- Crime & Disorder
- Public Safety

Mr Shaun Kayser Shafiq is both the premise licence holder and designated premises supervisor at the premises since 01/09/2006

The concerns relate to poor management at the premises resulting in potential criminal offences of unlicensed activity, namely the supply of alcohol at a time when the premise licence does not permit. Namely on the 17th February 2023 Mr Shafiq supplied a bottle of Glens Vodka to a male at 6:06 am, after leaving the premises the male collapsed and died in the street.

The information was received as part of a review into an alcohol related sudden death.

The supply of alcohol as a licensable activity is not permitted at the premises until 08:00 am.

In addition to this Mr Shafiq's denial of the offence and inability to recognise the seriousness of his actions raises concerns of understanding the impact availability of alcohol has on vulnerable people. I believe he knew the male was an alcoholic, he confirms this in his interview, in CCTV provided by an attending police officers body cam the male looks to be already intoxicated.

Although Mr Shafiq attend a formal PACE interview, he denied the allegation despite providing the police officer in attendance on the 17 February 2023 with a print out of a receipt showing the sale of vodka and the date and time.

I also believe Mr Shafiq has obstructed licensing officers in their investigation by not disclosing there are two CCTV systems at the premises and by not providing till receipts from the day in question, and for days preceding the event.

The decision to review the licence was also taken when immediately after interview Mr Shafiq, displaying no concern or remorse for the situation asked officers how he could increase the alcohol supply hours at the premises to 06:00, showing totally disregard for the investigation.

Following an application to review the above premises licence on 20 June 2023 from the Licensing Service acting as a Responsible Authority, please find attached additional information.

On the 27 March 2023 information was received from Public Health, a Drug and Alcohol Related Sudden Death meeting had been held following the sudden death of a male in Oxbridge. The details being a male had attended the Premier Mini Market on Oxbridge Lane early hours of the morning, purchased a bottle of Vodka and then died in Eton Road, Stockton.

On the 27 March 2023 my colleague Elliott Beevers attend the premises to view CCTV. Further details were received from police confirming the date of the death as 17 February 2023, my colleague attend the premises the next day again to view. A statement relating to this visits and correspondence between Mr Beevers with Mr Shafiq is attached as LMK1.

As CCTV from the premises was not available to view, I contacted Chief Inspector John Tapper at Cleveland Police, who had been at the joint agency Drug and Alcohol Sudden Death meeting, and he confirmed as PC Thomas Godber and PC Ricky Parkinson had attended the scene.

On the 11 April 2023 I spoke to PC Godber who confirmed to me he carried out house to house enquires, whilst PC Parkinson spoke to the Premier shop keeper. He confirmed PC Parkinson had body worn video (BWV) footage of the day. PC Godber also confirmed the deceased male had a bottle of vodka on him, as he has collapsed it has smashed in his pocket.

On the 25th April at 09:30 I met with Jon Tapper to view PC Parkinson's BWV – on viewing the CCTV I could see and Asian male in the shop who identified himself as 'Shaun', he can be heard confirming to the Police officer the details of a receipt from that morning which confirms a sale of Glens vodka at 06:06. Shaun can be heard saying he goes in there every day, and he knows the male is an alcoholic. Shaun shows the Police officer the internal CCTV from that morning, whilst watching this the Police officer states "he's stumbling all over".

As this is police CCTV, I was unable to get a copy of this footage. I requested statements from both officers at the scene.

Mr Shafiq attended interview on 31 May 2023, he was cautioned and decided to not be legally represented. Mr Shafiq did not admit to selling alcohol outside of the authorised hours. A copy of the summary of interview is attached as LMK2. The denial of the offence and inability to recognise the seriousness of his actions raises concerns of understanding the impact availability of alcohol has on vulnerable people. Mr Shafiq knew the now deceased male was had issues with alcohol. He clearly remembers some thing from that morning, like not borrowing a passer by his phone to call for an ambulance, but cannot remember other things like supplying the male with a bottle of vodka, nearly two hours before his licensable hours.

Mr Shaun Kayser Shafiq is both the premise licence holder and designated premises supervisor at the premises since 01/09/2006 and I would view him as solely responsible for the management and day to day operations at the premises. Mr Shafiq's immediate enquiry after interview, into increasing his alcohol hours should disregard for the relevance of the investigation and the seriousness of the incident.

On the 9 June 2023 I revisited Middlesbrough police station to review the BWV of the incident which confirmed Mr Shafiq sold the male a bottle of Glens Vodka 06:06 on 17 February 2023.

On the 12 June 2023 my Elliott Beevers visited the premises again and requested till receipts from Mr Shafiq, he claimed he was unable to get receipts from that far back and could only generate stock reports.

On 20 June 23 my Elliott Beevers emailed Mr Shafiq requesting till receipts or reports and gave a deadline of 7 days. Mr Shafiq replied via email advising he is seeking legal advice in relation to harassment and discrimination.

On the 20 June 23 after consideration I applied to review the premises licence.

PC Ricky Parkinson provided a statement dated 27/05/2023 which is attached as evidence as LMK3.

PC Tomas Godber provided a statement dated 13/06/2023 which is attached as evidence as LMK 4.

1. I am an Assistant Licensing Officer employed and authorised by Stockton Borough Council. I have been employed in the Licensing Team since September 2021 and part of my duties is to investigate possible offences relating to the Licensing Act 2003.
2. On Monday 27th March 2023 at approximately 15:50 I entered the Premier shop located at 75-81 Oxbridge Lane, Stockton-on-Tees. I walked to the till area where a male and female were standing and I asked if a Manager was in. The male indicated this was him. This male was Mr Shaun Kayser Shafiq who I now know to be the Designated Premises Supervisor and Premises Licence Holder of the premises.
3. I asked Mr Shafiq to view the CCTV to conduct enquires into an alleged incident. He asked me what this incident was, I didn't have all the details at this time but I asked to see the CCTV from 06:00 on Sunday 26th and Monday 27th. Mr Shafiq agreed to do this once he had fixed the till, which took him approximately 5 minutes.
4. Mr Shafiq then began to get the CCTV from his mobile device which he advised me was better than using the monitor behind the till. I asked him to find a camera that showed the point of sale area. During the time Mr Shafiq was fixing the till, I asked if he is the DPS which he said yes, I asked what time the premises opens which he said 07:00 till 19:00 and he also advised me he is the only person with keys to the premises.
5. Mr Shafiq showed me the CCTV from early hours Sunday 26th March and Monday 27th March 2023. I watched the footage from around 05:50 until 06:10 intermittently. This showed no alcohol sales, and the premises was not open. Mr Shafiq then showed me the footage which showed the shop open but no sale of alcohol taking place.

6. On Tuesday 28th March 2023 at approximately 09:15 I entered the Premier shop located at 75-81 Oxbridge Lane, Stockton-on-Tees. I walked to the till area where a member of staff was standing. I asked if Shaun was in today which they replied he was not. I asked if they could operate the CCTV which they could not and asked if they can see if Shuan can come and meet me.
7. The member of staff phoned Shaun then passed me the phone. I spoke to Shuan and advised him that the incident had now been confirmed 17 February 2023 and I now need to check the CCTV from the date I now have.
8. Shaun was unhappy he had to come and show me the CCTV again and said that he thought it had been dealt with yesterday. I advised him during this phone call that not having someone onsite who can access the CCTV is a breach of a condition on his licence. He also said I should have phoned and arranged an appointment with him for this. I explained in cirmstances such as viewing CCTV an unannocuned visit is best practice to avoid any tampering with any equipment. He agreed to meet me in an hours time at 10:20.
9. I left the premises at 09:24.
10. I returned to the premises an hour later at around 10:20 and met with Shaun. I advised him I need to view the footage on his CCTV from 17th February 2023. He advised he does not think it will go back that far but agreed to check for me. Shaun showed me that the footage from the till area would not go back until the 17th February and only went back until 24th March 2023. He showed me this date which I watched from 05:54 until 06:06 which showed the shop was not open at this time.
11. I advised Shaun that the CCTV licence condition states footage needs to go back 14 days and someone needs to be on duty who can use this.
12. I make this statement from the notes I made in my pocketbook at the time of my visit.
13. On 13 June 2023 I sent Shaun an email requesting till receipts from the 17th February 2023. Shaun replied on 13 June 2023 saying the till receipts do not store individual transactions.
14. After conducting further enquiries I noted that systems through Paypoint should store receipts. I emailed Shaun again on 20 June 2023 asking for the till receipts. He emailed back saying he does not have these and has already told me this. He advised he would be seeking legal advice for discrimination and harassment.

I am Police Sergeant 2757 Ricky Parkinson of Cleveland Police, currently stationed at Stockton Police Station and attached to the Incident Resolution Team.

I write this statement some three months after my initial attendance at the incident for the benefit of Stockton Council's licensing department in assisting their investigation.

On 17th February 2023 at about 0720 hours, I was on duty in uniform and assigned to call sign 06B as the shift's response sergeant. I was issued with Body Worn Video device serial, which I wore on my uniform in an overt manner and marked evidential on the NICE system.

At about this time, the Force Control Room requested me to attend the road side of 13 ETON ROAD, STOCKTON on an emergency response, following a report of ambulance attending a sudden death of a male unknown at the time (but later identified as ██████████ ██████████). PC 2858 Johnstone and PC 3305 Godber were already on scene with ambulance when I arrived.

My actions on scene were to establish the circumstances of the death, and to eliminate the possibility of the death being suspicious through a primary investigation as well as to establish the deceased's identity. A part of these enquiries was to conduct CCTV checks. According to the CAD attached to the event, 0736Hrs was the time I shouted to comms to alert them to the existence of CCTV showing that at 0606Hrs on the morning of the incident, [REDACTED] is served by the shopkeeper when he purchases 1 x bottle of Glenn's vodka from PREMIER STORE, OXBRIDGE LANE. He shortly after leaves the shop and collapses where he is later discovered deceased.

At the time, I activated my BWV device and announced that my BWV device was recording both video and audio. This captured my interaction between myself and the shopkeeper who explained that he knew the deceased and has regularly served him at around the same time every morning, noting that he was an alcoholic.

This is all the information I can offer to assist Stockton Borough Council in their investigation. My BWV footage shows the entire interaction and may be available through request.

I am the above named officer currently employed by CLEVELAND POLICE, currently attached to IRT NORTH, STOCKTON B RELIEF.

On FRIDAY the 17th of FEBRUARY 2023 I was in full Police uniform conducting a marked mobile patrol in crew with my colleague, PC 2858 JOHNSTONE.

On this date at 0716hrs myself and PC 2858 JOHNSTONE attended 13 ETON ROAD, STOCKTON, in response to a call from ambulance staff who had responded to deceased male in the street. Upon our arrival on scene, we were shortly joined by SGT 2757 PARKISON. Upon speaking to ambulance staff, they informed myself and my colleagues that they had been called by a member of the public who had stated that they had found the male laying face down in the street. The member of the public also told ambulance staff that they had rolled the male over and attempted to give him CPR prior to their arrival, however, on paramedics arriving on scene they declared the male to be deceased.

Paramedics on scene also stated that the member of the public had given the name [REDACTED] and further stated that prior to Police arriving at the scene the male had stated he needed to be somewhere and left.

Upon searching the deceased male's body, who I now know to be [REDACTED], myself and PC 2858 JOHNSTONE located a small amount of change, a smashed vodka bottle,

house keys, a receipt and some coughing sweets. Upon further examination of [REDACTED] body there were visible signs of blood pooling, consistent with how [REDACTED] had been laid on the floor prior to being found. There were also some signs of bruising to [REDACTED] body, which were later deemed as being not suspicious due to [REDACTED] having collapsed onto concrete before his death and also the male being an alcoholic, suggesting he may have fallen over regularly.

Following this, I then conducted house to house enquires along the street where [REDACTED] was found at addresses which had ring doorbells next to where [REDACTED] had been found and his neighbours address. None of the persons who I spoke to stated that they had seen or heard anything, however, one neighbour did state that he usually sees a male walk past his living room window every morning to visit the PREMIER STORE on OXBRRIDGE LANE. The male also stated that he had not seen this male, presumed to be [REDACTED], walk past his living room window on this morning.

SGT 2757 then informed me that he had reviewed CCTV from the premier store which looked directly up ETON ROAD and stated that the CCT footage showed [REDACTED] collapse and not get back up again. SGT 2757 PARKINSON also informed me that [REDACTED] had visited the premier store that morning and bought one bottle of vodka before leaving the store and walking up ETON ROAD. SGT 2757 further asked if me or PC 2858 had found a mobile phone on [REDACTED] body as this is what he used to pay with. Upon stating we had not I began to conduct an area search for the mobile phone in the area where [REDACTED] had been found with the thought in mind, he may have dropped the phone upon collapsing. No mobile phone was located in the area and [REDACTED] body was then transported to NORTH TEES HOSPITAL by ambulance staff.

I am a Police Constable in Cleveland Police presently stationed at Middlesbrough Police station in the Licensing Support Unit.

I have performed this role for over 10 years and during that time I have successfully completed the BIIAB level 2 National Certificate for Licensing Practitioners and the BIIAB level 2 course in the Assessment of Licensed Premises.

I am making this statement in support of the review application brought against Premier Mini Market, 75-81 Oxbridge Lane, Stockton. The review has been brought by the council as the DPS Mr Shaun Kayser SHAFIQ has shown that he is undermining the Licensing Objectives for Prevention of Crime and Disorder and Public Safety.

As a responsible authority Cleveland Police believe that anyone supplying alcohol to the public have a responsibility to the public and the surrounding community and must uphold the Licensing Principals whilst abiding by the conditions of their premise licence including the times they are allowed to carry out licensable activities.

I have submitted CCTV footage captured from the Body Worn Video of a police officer investigating the sudden death of a male in the street outside the premises and evidence this

footage as AT/1 for the purposes of this review. The footage clearly shows Mr SHAFIQ telling the officer that the male had been into his store earlier that day and showing the police officer a copy of the receipt which he had printed from the system telling the officer that the receipt had the males bank details on it and it showed what the male bought in the shop that morning. The footage showed the officer confirming with Mr SHAFIQ that it was a bottle of Glens Vodka the male bought. Mr HAFIQ then showed the officer the footage of the male attending the store that morning to make his purchase of Vodka confirming the time the male attended the store at 06:06 hours that morning. Mr SHAFIQ's premise licence clearly states that they are only allowed the supply of Alcohol from 08:00 hours at the earliest (on Sundays they can only supply alcohol from 10:00 hours). This means that by selling the male alcohol just after 06:06 hours he was breaching the terms of his premise licence.

The conditions of the licence are there to protect the premise licence holder and the patrons using the premise and as such are not merely guidelines but a code of conduct and should be always adhered to.

It is clear that Mr SHAFIQ does not think he has done, or is unaware that he has done anything wrong, which indicates that he is not familiar with the licensable hours, and as DPS should be, or he is flagrantly disregarding the terms of his licence.

Cleveland Police support our partners Stockton Borough Council Licensing in bringing this review application as every license should be adhered to as infringements can often lead to more catastrophic results.

- **(1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.**

(2) The designated premise supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

Where-

- (i) P is the permitted price
 - (ii) D is the amount of duty chargeable in relation to the alcohol as if duty were charged on the date of the sale or supply of the alcohol, and
 - (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
- (i) the holder of the premises licence,
 - (ii) the designated premise supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994

C. Where the permitted price given by Paragraph (b) of paragraph B would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny

D. (1) Sub-paragraph (2) applies where the permitted price given by paragraph (b) of paragraph B on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

EMBEDDED RESTRICTIONS

- **Off Licences and off sales depts of on licensed premises
Permitted Hours**

Alcohol shall not be sold or supplied except during permitted hours.

In this condition, permitted hours means:

- a) On weekdays, other than Christmas Day, 8.00am to 11.00pm
- b) On Sundays, other than Christmas Day, 10.00am to 10.30pm
- c) On Christmas Day, 12 Noon to 3.00pm and 7.00pm to 10.30pm
- d) On Good Friday, 8.00am to 10.30pm

The above restrictions do not prohibit:

- a) During the first twenty minutes after the above hours, the taking of the alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;
- b) The ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- c) The sale of alcohol to a trader or club for the purposes of the trade or club;
- d) The sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's Naval, Military or Air Forces.

- Off-Licence Consumption

Alcohol shall not be sold in an open container or be consumed in the licensed premises.

ANNEX 2

CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

PREVENTION OF CRIME & DISORDER

- A digital Closed Circuit Television System (CCTV) must be installed and maintained. The system must incorporate sufficient built-in hard-drive capacity to suit the number of cameras installed, whilst complying with the Data Protection legislation.

A minimum of 14 days recording is required.

The system must have a minimum of a simplex multiplexing facility and be recording for 24 hours a day.

The system must incorporate a means of transferring images from the hard-drive to a format that can be played back on any desktop computer.

The digital recorder must have the facility to be password protected to prevent unauthorised access, tampering, or deletion of images.

There must be at all times a member of staff on duty who is trained in the use of the equipment and upon receipt of a request for footage from a governing body, such as Cleveland Police or any other Responsible Authority, be able to produce the footage within a reasonable time, e.g. 24hrs routine or less if urgently required for investigation of serious crime.

PROTECTION OF CHILDREN FROM HARM

- A 'Challenge 21' policy will be implemented with all staff insisting on evidence of age from any person appearing to be under 21 years of age and who is attempting to buy alcohol. There shall be sufficient public notices displayed at the premise to inform customers and remind staff that the premise is operating a 'Challenge 21' policy.

- **All staff will be trained with regard to the law concerning the sale of alcohol and also the operation of the associated 'Challenge 21' policy. Staff will receive refresher training at least every 3 months.**
- **Training records, signed by both the staff member and the Designated Premise Supervisor/Store Manager/Business Owner will be retained for future reference and shall be updated at least every 3 months. All staff training records will be made available to Enforcement Agencies and/or Responsible Authorities upon request.**
- **There shall be adequate notices displayed on the premise indicating that the sale of alcohol to those under the age of 18 is illegal and that those adults who buy alcohol for immediate disposal to those under the age of 18 are committing an offence.**
- **The business will maintain a refusals book to record all instances where the sale of age restricted products have been refused. This shall include the date and time of the attempted sale, together with a description of the incident. The Designated Premises Supervisor and/or the Premises Licence Holder will check and sign each page and the refusals book shall be made available to Enforcement Agencies and/or Responsible Authorities on request.**
- **The only acceptable evidence of age will be a valid photo identification confirming the purchasers age, namely a passport, photo driving licence or PASS approved proof of age card such as a Validate Card, Portman Card or Citizen Card.**

I am a Police Constable in Cleveland Police presently stationed at Middlesbrough Police station in the Licensing Support Unit.

I have performed this role for over 10 years and during that time I have successfully completed the BIIAB level 2 National Certificate for Licensing Practitioners and the BIIAB level 2 course in the Assessment of Licensed Premises.

I am making this statement in support of the review application brought against Premier Mini Market, 75-81 Oxbridge Lane, Stockton. The review has been brought by the council as the DPS Mr Shaun Kayser SHAFIQ has shown that he is undermining the Licensing Objectives for Prevention of Crime and Disorder and Public Safety.

As a responsible authority Cleveland Police believe that anyone supplying alcohol to the public have a responsibility to the public and the surrounding community and must uphold the Licensing Principals whilst abiding by the conditions of their premise licence including the times they are allowed to carry out licensable activities.

I have submitted CCTV footage captured from the Body Worn Video of a police officer investigating the sudden death of a male in the street outside the premises and evidence this

footage as AT/1 for the purposes of this review. The footage clearly shows Mr SHAFIQ telling the officer that the male had been into his store earlier that day and showing the police officer a copy of the receipt which he had printed from the system telling the officer that the receipt had the males bank details on it and it showed what the male bought in the shop that morning. The footage showed the officer confirming with Mr SHAFIQ that it was a bottle of Glens Vodka the male bought. Mr HAFIQ then showed the officer the footage of the male attending the store that morning to make his purchase of Vodka confirming the time the male attended the store at 06:06 hours that morning. Mr SHAFIQ's premise licence clearly states that they are only allowed the supply of Alcohol from 08:00 hours at the earliest (on Sundays they can only supply alcohol from 10:00 hours). This means that by selling the male alcohol just after 06:06 hours he was breaching the terms of his premise licence.

The conditions of the licence are there to protect the premise licence holder and the patrons using the premise and as such are not merely guidelines but a code of conduct and should be always adhered to.

It is clear that Mr SHAFIQ does not think he has done, or is unaware that he has done anything wrong, which indicates that he is not familiar with the licensable hours, and as DPS should be, or he is flagrantly disregarding the terms of his licence.

Cleveland Police support our partners Stockton Borough Council Licensing in bringing this review application as every license should be adhered to as infringements can often lead to more catastrophic results.

The Public Health team have reviewed the evidence provided by licensing colleagues, in respect of the Premier Mini Mart on Oxbridge Lane. The concerns relate to the licence holder, Mr Shaun Kayser Shafiq, who, based on his actions, is a risk to a vulnerable population – which will be outlined below.

After considering the information provided, Public Health is in full support of the review application submitted by SBC Licensing, and would like to comment further on the following – which we feel significantly undermine the licensing objectives of **Prevention of Crime and Disorder**, and **Public Safety**:

- The sale of alcohol at a time when the premise licence does not permit
- The sale of alcohol to an individual who, based on CCTV evidence provided, looks to be intoxicated
- The obstruction of licensing officers carrying out an investigation related to the above offences

Public Health supports all aspects of promoting the licensing objectives, particularly, protecting the health of the Borough and local communities; and protecting the public and children from harm, by ensuring the Borough is a safe place to live.

Public Health recognises the variety of harms associated with alcohol, including:

- Physical health harms to an individual, including increased risk of cancer, stroke, dementia, and heart attacks
- Mental health harms to an individual, including increased risk of anxiety and depression
- Wider, community harms; in that alcohol is a significant contributor to crime, factoring in 39% of all violent crimes in England. It has a significant role in perpetration of domestic violence, child neglect, and abuse and exploitation of vulnerable individuals.
- Health inequalities, in that, people of a lower Socioeconomic Status (SES) are more likely to experience greater alcohol-related harm, even at the same or lower levels of alcohol intake than people of a higher SES.

It is crucial to acknowledge the ward in which Premier Mini Mart is situated - Stockton Town Centre - which is ranked the worst in the Borough for the following datasets: consumption and associated alcohol related harm, crime and disorder.

- Outlet density
- Hospital stays for alcohol related harm
- All crime under the influence of alcohol
- Violent crime under the influence of alcohol
- Admissions wholly attributable to alcohol
- Admissions partially attributable to alcohol
- Hospital admissions for self-harm
- Rates of reported domestic abuse

As such, the availability and accessibility of alcohol is a particular concern for populations within this ward, due to potential individual, and wider community harms. It is commonly accepted in the evidence that if the opening hours of alcohol sale are extended, incidences of violence increase, affecting the wider community and directly contravening the two aforementioned licensing objectives. Locally, the view of restricting hours available for alcohol sale is popular in Stockton-on-Tees – in 2017, 62% of respondents supported restricting alcohol sales in off licences to between 10am and 10pm (Balance, 2017). Similarly, 43% of respondents felt there are too many off-licences, supermarkets, and shops, that sell alcohol.

Further, international evidence suggests that making it less easy to buy alcohol, by reducing the number of outlets selling it in a given area, and the hours and days when it can be sold, is an effective way of reducing

alcohol-related harm. Given the outlet density in Stockton Town Centre – and the attempts by the licence holder to extend the hours of sale to 6:00am, despite the implications on the health of vulnerable populations – this is of particular concern to Public Health.

In the context of the evidence above, in order to prevent further undermining of the licensing objectives of Prevention of Crime and Disorder & Public Safety - and further risk to Public Health - Public Health fully supports the review application submitted by SBC Licensing.
