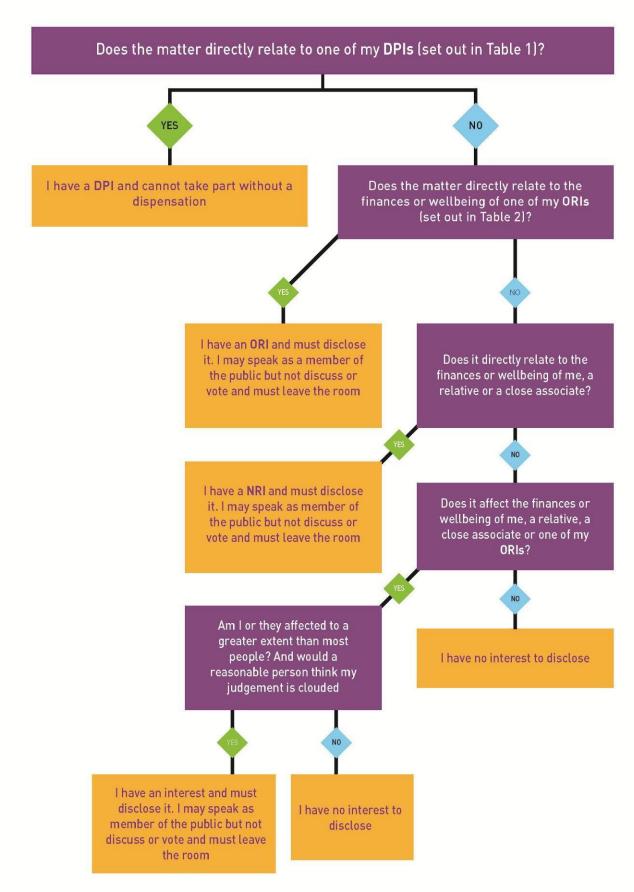




Table 1 - Disclosable Pecuniary Interests

Subject	Description
Employment, office, trade, profession or vocation	Any employment, office, trade, profession or vocation carried on for profit or gain
Sponsorship	Any payment or provision of any other financial benefit (other than from the council) made to the councillor during the previous 12-month period for expenses incurred by him/her in carrying out his/her duties as a councillor, or towards his/her election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.
	Any contract made between the councillor or his/her spouse or civil partner or the person with whom the councillor is living as if they were spouses/civil partners (or a firm in which such person is a partner, or an incorporated body of which such person is a director* or
Contracts	a body that such person has a beneficial interest in the securities of*) and the council — (a) under which goods or services are to be provided or works are to be executed; and
	(b) which has not been fully discharged.
Land and property	Any beneficial interest in land which is within the area of the council. 'Land' excludes an easement, servitude, interest or right in or over land which does not give the councillor or his/her spouse or civil partner or the person with whom the councillor is living as if they were spouses/ civil partners (alone or jointly with another) a right to occupy or to receive income.
Licences	Any licence (alone or jointly with others) to occupy land in the area of the council for a month or longer.
Corporate tenancies	Any tenancy where (to the councillor's knowledge)— (a) the landlord is the council; and (b) the tenant is a body that the councillor, or his/her spouse or civil partner or the person with whom the councillor is living as if they were spouses/ civil partners is a partner of or a director* of or has a beneficial interest in the securities* of.
Securities	Any beneficial interest in securities* of a body where— (a) that body (to the councillor's knowledge) has a place of business or land in the area of the council; and (b) either— (i) the total nominal value of the securities* exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the councillor, or his/ her spouse or civil partner or the person with whom the councillor is living as if they were spouses/civil partners have a beneficial interest exceeds one hundredth of the total issued share capital of that class.

^{* &#}x27;director' includes a member of the committee of management of an industrial and provident society.

^{* &#}x27;securities' means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.



Table 2 – Other Registerable Interest

You must register as an Other Registrable Interest:

- a) any unpaid directorships
- b) any body of which you are a member or are in a position of general control or management and to which you are nominated or appointed by your authority
- c) any body
- (i) exercising functions of a public nature
- (ii) directed to charitable purposes or
- (iii) one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union) of which you are a member or in a position of general control or management

CONSENT STREET TRADING (CST) RESOLUTION

SUMMARY

This report addresses the motion submitted by Councillor Ted Strike at the Council meeting on 29 May 2024, concerning the resolution agreed under the Local Government Miscellaneous Provisions Act 1982 which designated the whole Borough as a consent area for the purposes of street trading. This motion has been automatically referred to the General Licensing Committee for comments.

THE MOTION

The motion submitted to the Council reads:

"Whilst we recognise the need to update the regulations on the "Consent Street Trading Policy" the current rules are penalising craft stalls, Farmers markets and community events, something I am sure was never intended.

That Council, at the earliest opportunity amend the current rules to exclude all community events and Farmers Markets from these charges. These include, but are not limited to:

Ingleby Barwick Family Fun Weekend
Ingleby Barwick Community Market
Ingleby Barwick Light Switch on
The Thornaby Show
The Billingham Show
The Festival of Thrift
Northern Dales Farmers Markets
Norton Green Market"

RECOMMENDATIONS

1. That Members comments are received.

DETAIL

 Following a statutory consultation process, under Paragraph 2(1) of Schedule 4 to the Local Government (Miscellaneous Provisions) Act 1982, the Council has agreed to designate the whole Borough as a consent area for the purposes of street trading. A notice of the final resolution was published in a local newspaper and on the Council website advertising the decision, and confirming the CST resolution came into force on 1 March 2024. A time line of the full process is attached at Appendix 1.

- 2. For clarification following the statutory public consultation and in response to concerns around fundraising several changes were made to the procedural guidance. A copy of the procedural guidance used in this licensing regime can be found at www.stockton.gov.uk/street-trading-consent
- 3. To date several CST applications and enquiries have been received and are detailed at Appendix 2.

Financial Implications

Fee setting is delegated to officers under the Councils constitution. The cost of administering the consent street trading scheme can be recovered through street trading fees, which are set locally and reviewed annually. The fees must be set at a level to recover the cost of the scheme and can take into account the location, the duration of the consent, trading hours, and the articles to be sold.

Environmental Implications

Through the maintenance of a strategic licensing policy there will be opportunities to further improve the environment, to the benefit of all.

Legal Implications

Stockton Borough Council has designated the whole of the Borough as a consent area in accordance with the powers granted in Section 3 and Schedule 4 of the LG(MP) Act 1982.

Community Safety Implications

The administration and enforcement of the licensing regime should assist in reducing crime and disorder.
